Report of the Rules Committee on amendments to the Standing Rules dated 10 October 2013.

The Rules Committee, having considered proposed amendments to the Standing Rules on 10 October 2013, begs to recommend amendments as follows:

RULE 63

After sub rule (2) to add:

- (3) The presiding officer may request a Member to provide him/her with the text of the explanation prior to making a decision on whether to grant an opportunity for an explanation.
- (4) An explanation may not –
 - (a) contain offensive language;
 - (b) court controversy;
 - (c) debate the matter; or
 - (d) contain charges or attacks on another Member.

RULE 79

To omit sub rule (2), and to substitute ‘(2) A committee may decide a question only if a majority of the members on the committee is present.’.
