#### 1. Opening and welcome

The Chairperson opened the meeting and welcomed the members of the Committee, the Departmental and CapeNature officials, representatives from SALGA, and the officials from the Western Cape Provincial Parliament.

# 2. Briefing by the Department of Environmental Affairs and Development Planning on the implementation of the Western Cape Biodiversity Act, 2021 (Act 6 of 2021) and the associated Regulations

The Department provided the Committee with background information pertaining to the Western Cape Biodiversity Act and explained the phased implementation approach of certain sections of the Act.

The Department further informed the Committee of the drafting of the associated regulations that were ongoing, and that these needed to be aligned to the developing national policy, law and other regulations. Key outputs required by the Act were expanded upon. Key considerations within the context of the Act on a global, national and provincial level were highlighted and explained.

The Committee deliberated.

#### 3. Resolutions/Actions

The Committee REQUESTED that the Department provides it with:

- 3.1 The timeframe for the first round of stakeholder engagements on the regulations and an update in terms of the outcome of these engagements after the first round of engagements in August 2023;
- 3.2 A copy of the draft regulations before publication; and
- 3.3 Further detail on the public engagement process, with specific reference to the list of stakeholder groups that were identified by the Department and CapeNature as organised and less organised sectors.

#### 3. Consideration and adoption of Draft Committee Minutes

The Chairperson submitted the Draft Committee Minutes of the meetings held on 28 November 2022 at 12:00 and 28 November 2022 at 14:00, which were considered and adopted.

# 4. Consideration and adoption of Draft Committee Quarterly Report

The Chairperson submitted the Draft Committee Quarterly Report (September – December 2022), which was considered and adopted.


#### 5. General

- 5.2.1.2 Send a letter of appreciation to the Department of Water and Sanitation for the completion of the Project.

The Chairperson expressed his appreciation to the members, the Departmental and CapeNature officials as well as the officials from the Western Cape Provincial Parliament for their contribution to the success of the meeting.
