4. Consideration and adoption of Draft Committee Minutes of the meeting held on 29 November 2022


The Chairperson submitted the Draft Committee Minutes of the meeting held 29 November 2022, which was considered and adopted.

- 4.3 That political parties present, at the next workshop, indicating their views on the drafts of the Standing Rules and the Money Bills Amendments Procedure Bill.
