- 3.3. An update on the outcomes of the Department's meeting with the Department of the Premier and the Department of Infrastructure, on the progress and future of the Archives building.
- 3.4. An update on the maintenance and governance processes, and the type of support given to the Drostdy Museum.
- 3.5. A report on the state of readiness for the forthcoming Initiation Season.
- 3.6. A list of the libraries that are not yet equipped with internet connectivity and timelines for the implementation of the internet connectivity at these sites.
