# 1. Welcome and attendance

The Chairperson opened the meeting welcomed the members, Provincial Treasury officials and members of the public to the meeting to deliberate on Vote 12: Department of Economic Development and Tourism in the Schedule to the Western Cape Appropriation Bill [B 1-2024]. Committee supported Vote 12: Department of Economic Development and Tourism, in the Schedule to the Western Cape Appropriation Bill, and that the African National Congress and

Al Jamah-Ah expressed their minority views, in accordance with Standing Rule 90, to not

support the Vote.

The meeting adjourned at 15h30.


