1. Welcome and apologies

Ms Kaizer- Philander indicated that she is representing Ms N Mbombo.

2. Election of Chairperson

The Procedural Officer, Mr D Davids, welcomed the Committee members and informed the Committee that in accordance with the Western Cape Provincial Parliament's Standing Rule 82(1) the Committee would proceed to the election of a chairperson.

The Procedural Officer responded that there was no rule in the Standing Rules of the Western Cape Provincial Parliament which indicated that an Alternate Member could not nominate or participate in any committee meeting, barring that the alternative members could not vote if the Member of the Committee was in the meeting and have full voting rights which the alternate members then did not have in this specific instance. Mr Bosman and Ms Nkondlo thanked the Procedural Officer for the clarification on the enquiry.

The Procedural Officer proceeded to request the Committee to vote, seeing that two names have been tabled for Chairperson of the Committee.

Ms Lekker voted for herself as Chairperson of the Public Accounts Committee (as a permanent member of the Committee).


