1. Welcome and apologies

- 4.2. the FFC brief and engage the Committee in detail on its presentation on the public health inefficiencies in the district health sector in South Africa and the Western Cape in terms of the shortages and exodus of healthcare workers;
- 4.3. the FFC brief and engage the Committee in detail on the infrastructure challenges and support offered to the small scale farmers in South Africa; including the Western Cape;
- 4.4. the FFC provide feedback on its relationship and interactions with the national and provincial ministries of finance; including the local government sphere, and
- 4.5. the FFC submit a Report to the Committee on its findings on the culture, work ethics and financial status of the municipalities in South Africa and the Western Cape; including the South African Local Government Association (SALGA).

After concluding on its deliberations, the meeting adjourned at 13:20.
