1. Welcome and Attendance

4. Consideration and adoption of Draft Committee Minutes

The Committee considered and adopted the draft minutes of 27 September and 17 October 2024 without any amendments.

5. Discussion and Resolution on the Committee's Proposal for an International Study Tour


The Chairperson opened the discussion indicating that a request was sent to the Western Cape Provincial Parliament's Research Unit to submit research on cities with integrated transport systems, specifically where minibus taxis have been integrated into the system.

The Chairperson noted that the research request has already been enacted and a preliminary search indicated that Jakarta, Mexico City and Istanbul would be possible options for the Committee to explore. Further research then showed that Istanbul and Mexico City were not viable options, and the Research Unit was then instructed to provide more options.

The Chairperson noted that the Committee should resolve on its intention to do an international study tour on integrated transport systems so this intention could be communicated to the Speaker as soon as possible.

The Committee agreed to the proposal for the international study tour and to wait for the research on Jakarta, which would be submitted by 22 November 2024. The new case studies would then be submitted by 10 December 2024.

The meeting adjourned at 14:07.
