The Minister and the Department briefed the Committee on the Draft Provincial Land Transport Framework and the interventions undertaken by the Department to address the challenges identified in the mobility sector.

The Committee proceeded to the question-and-answer session once the presentation concluded.

3. Consideration and adoption of Draft Committee Minutes

The Committee considered and adopted the draft minutes of 12 and 28 November 2024, and 7 February 2025 without any amendments.

4. Resolutions/Actions

- 4.1.1 To hold the briefing with the Passenger Railway Agency of South Africa at an external site, to be decided by the Committee;
- 4.1.2 To invite the Minister of Mobility and the Western Cape Mobility Department to brief the Committee on the proposal for the Overstrand non-motorised transport project; and
- 4.1.3 To include Go George public bus service and MyCiTi integrated rapid transit system in the Committee's oversight plans.
- 4.2 The Committee REQUESTED the following from the Western Cape Mobility Department:
- 4.2.1 An infographic or a shortform information sheet on the Draft Provincial Land Transport Framework (if the Department possesses such a document), that may be distributed to members of the public; and
- 4.2.2 A brief report breaking down the Department's financial projections for the Draft Provincial Land Transport Framework.
