## **1. Welcome and attendance**

The Chairperson opened the meeting and allowed brief introductions by the Minister and the Acting Head of Department. Member Herron submitted an apology, indicating that he would need to depart the meeting early.

## **2. Consideration of Vote 8: Western Cape Mobility Department in the Schedule to the Western Cape Appropriation Bill [B 2-2025]**

The Minister and Acting Head of Department gave introductory remarks on the budget for Vote 8: Western Cape Mobility Department. The Committee proceeded to a discussion on the Vote.

The Committee deliberated and engaged the Department on Vote 8. The Chairperson thanked the Department's officials and the Minister for the preparation and responses to the questions raised by the Committee Members.

The Chairperson noted that there were no questions or comments raised by members of the public.

The Committee proceeded to express their views on the Vote.

## **3. Consideration and adoption of the draft Committee Report on Vote 8: Western Cape Mobility in the Schedule to the Western Cape Appropriation Bill [B 2-2025]**

The Chairperson submitted the draft Committee Report, which was considered and adopted.

In accordance with Standing Rule 90, the African National Congress (ANC) expressed its Minority View to not support the Vote.

## **4. Resolutions/Actions**

4.1 The Committee REQUESTED that the Western Cape Mobility Department provide it with a comprehensive report on the Electronic Minibus Taxi pilot project, specifically addressing (i) the collaboration between Stellenbosch University and Rham Equipment in developing the electric minibus taxi, and (ii) the Department's strategy to promote the adoption/uptake of electronic vehicles within the Western Cape's informal transport sector, specifically, the minibus industry.

4.2 The Committee RESOLVED the following:

4.2.1 To request a briefing from the Western Cape Mobility Department on the Western Cape Freight Strategy and Western Cape Freight Demand Model, developed in collaboration with CASIDRA and the City of Cape Town; and

4.2.2 To request a briefing from the City of Cape Town on the proposed plan/strategy for the devolution of rail to provinces, and the corresponding national policy addressing this matter.

The meeting adjourned at 16:36.
