**1. Opening and Welcome, Interviews of Candidates to Fill the Vacancy on the Western Cape Gambling and Racing Board, Deliberations on the Interviews, and Consideration and Adoption of the Draft Committee Report on the Recommendations of Candidates to Fill the Vacancy on the Western Cape Gambling and Racing Board**

The Chairperson opened the meeting and welcomed all in attendance to the interviews of candidates nominated to be appointed to the Western Cape Gambling and Racing Board (the Board). The Chairperson noted the apology from Member D Wessels, also noting that Member B van Minnen (DA) would be standing in for him.

The Chairperson reminded the Committee that a resolution was taken at the meeting of 29 April 2025 that the discussions regarding the interview questions, and the interviews themselves, would be closed to the public.

In accordance with the Standing Rule 74, "The proceedings of or the evidence taken by or the report of a committee, while its proceedings were conducted *in camera*, or a summary of such proceedings, evidence or report, may not be published or divulged before the report has been printed on the authority of the Speaker or by order of the House, provided that evidence which such a committee has resolved may not be made public, may not be published or divulged.

The Committee finalised the interview questions, held the interviews with the six candidates, deliberated on the interviews, and considered and adopted the Draft Committee Report on the Recommendation of Candidates to Fill the Vacancy on the Western Cape Gambling and Racing Board.
