### **1. Welcome and attendance**

The Chairperson welcomed the Members, the delegation from the North West Provincial Legislature, the Minister of Finance, the officials from the Provincial Treasury and members of the public to the meeting.

The Chairperson informed the Committee that the visiting delegation was from the North West Provincial Legislature's (NWPL) Portfolio Committee on Premier and Finance. The NWPL had requested an engagement with the Western Cape Provincial Parliament's Standing Committee on Finance to discuss the Western Cape's best practices in respect of conducting oversight on Public Private Partnerships (PPPs) in the province. In its correspondence to the WCPP, the North West indicated that the rationale for the visit was to engage in a benchmarking exercise with the Standing Committee to empower the Members of the NWPL to create a framework that will best serve their province in efficiently fast-tracking infrastructure delivery through PPPs.

The Chairperson handed over to the Minister and the Provincial Treasury to present on the agenda items.

### **2. Briefing by the Minister of Finance and the Provincial Treasury**

The Minister and officials from the Provincial Treasury briefed the Committee on the Fiscal Futures Model, Alternative and Blended Finance and their role in respect of PPPs.

The Committee Members and the Members belonging to the NWPL were allowed the opportunity to ask questions based on the presentations that were made.

### **3. Resolutions/Actions**

The Committee RESOLVED the following:

- 3.1 To invite the Minister of Finance and the Provincial Treasury to continue the discussions on the information presented on the Fiscal Futures Model, Alternative and Blended Finance, and Public Private Partnerships; and
- 3.2 To allow the Members to send any additional questions they had for the Minister of Finance and Provincial Treasury to the Procedural Officer, which would be answered in writing.

The meeting adjourned at 11:45.
