#### 1. Opening and welcome

The Chairperson opened the meeting and welcomed the members of the Committee, the Acting Head of Department, the Chief Executive Officer of Casidra, departmental officials, and those who were watching the live proceedings on YouTube.

The Chairperson briefed all attendees on the video conferencing protocols and outlined the objectives of the meeting.

# 2. Briefing by the Department of Agriculture and Casidra on its non-financial quarterly performance for the period January - March 2025 (Quarter 4)

The Department and Entity briefed the Committee on its respective Quarterly Performance Reports highlighting with reason the targets that were not achieved as well as those that were partially achieved within the various programmes.

The Committee deliberated.

#### 3. Briefing by the Department of Agriculture on the status of land use management

The Department briefed the Committee on the status of land use management and land rezoning for various purposes, as well as the current risks to preserving agricultural land within the province. The Committee was informed that productive agricultural land was under severe pressure due to requests for other uses such as expansion of the urban edge, housing estate developments and renewable energy generation.

The Department further briefed the Committee on its readiness to implement the Preservation and Development of Agricultural Land Act, 2024 (Act 39 of 2024). It was noted that the national Department of Agriculture has not developed the necessary regulations and norms to give effect to the implementation of the Act. Consequently, the Western Cape Department of Agriculture was not able to assume the functions expected to be delegated to provinces. The development of provincial regulations and norms was dependent on the finalisation of the national framework, and the identification of provincial protected agricultural areas could only proceed once the corresponding national protected areas were established.

- 5.1.2 The latest external Evaluation Report on food security projects.
- 5.2 The Committee REQUESTED that the Department of Agriculture provides it with the:
- 5.2.1 Standard Operating Procedure that outlines the land use application process; and
- 5.2.2 Number of land use applications that the Department commented on in the previous and current financial year.

The Chairperson expressed his appreciation to the members and officials for their contribution to the success of the meeting.
