1. Welcome and Attendance

The Chairperson welcomed the Members, the Minister of Finance and the officials from the Provincial Treasury (the Department) to the meeting. The Chairperson noted apologies from Member N Masipa (DA), Member N Mbombo (DA), and Member N Nkondlo (ANC).

The Chairperson noted that this meeting was a follow-up discussion to the presentations made by the Provincial Treasury on 12 June 2025, which looked at the Fiscal Futures Model, the Alternative and Blended Finance Framework, and the Department's role in overseeing Public-Private Partnerships (PPPs).

2. Follow-up Discussion on the Fiscal Futures Model, the Alternative and Blended Finance Framework, and Public-Private Partnerships

The Chairperson allowed the Minister and Department to make opening remarks and to summarise the presentations that were made on 12 June 2025.

Once the presentations concluded, the Members were afforded the opportunity to ask questions related to the presentations.

3. Consideration and adoption of Draft Committee Documents and Draft Committee Minutes

The Committee considered and adopted the Draft Annual Activities Report for the 2024/25 financial year.

The Committee considered and adopted the Draft Oversight Report on the visit to GrandWest Casino's Corporate Social Investment initiatives.

The Committee considered and adopted the Draft Committee Minutes of 2 April, 29 April, 13 May, 5 June and 12 June 2025.

4. Resolutions/Actions

The Committee REQUESTED that the Provincial Treasury provides the following:

- 4.1 A report outlining how Public Private Partnership (PPP) contract structures relate to Construction Industry Development Board (CIDB) requirements;
- 4.2 A report detailing the average CIDB grading required for contractors in provincial PPP projects; and

4.3 Verification of the municipal report regarding the Beaufort West reclamation plant, including (i) confirmation whether such a PPP is currently in place, and (ii) if confirmed, more information on the status of the PPP agreement.
