1. Opening and welcome

2. Briefing on the Provincial Treasury's Draft Annual Performance Plan for 2025/26 and the Third and Fourth Quarterly Performance Reports for 2024/25

The Minister of Finance and the Provincial Treasury briefed the Committee on the Annual Performance Plan (APP) for the 2025/26 financial year, and the Third and Fourth Quarterly Performance Reports for the 2024/25 financial year.

The Members were afforded the opportunity to ask questions to the Minister and Provincial Treasury once the presentations concluded.

Following the discussion, Members noted their dissatisfaction with quality of the presentations, which they thought did not include sufficient information on the APP and quarterly reports.

3. Consideration and Adoption of Draft Committee Minutes

The Committee considered and adopted the Draft Committee Minutes of 12 and 19 August 2025, without amendments.

4. Resolutions/Actions


3.1 The Committee RECOMMENDED that the Provincial Treasury should provide more detailed presentations at these future engagements so that Members do not have to interrogate every target.
