2. Briefing on the Provincial Treasury's Draft Annual Performance Plan for 2025/26 and the Third and Fourth Quarterly Performance Reports for 2024/25

The Minister of Finance and the Provincial Treasury briefed the Committee on the Annual Performance Plan (APP) for the 2025/26 financial year, and the Third and Fourth Quarterly Performance Reports for the 2024/25 financial year.

The Members were afforded the opportunity to ask questions to the Minister and Provincial Treasury once the presentations concluded.

Following the discussion, Members noted their dissatisfaction with quality of the presentations, which they thought did not include sufficient information on the APP and quarterly reports.


3. Consideration and Adoption of Draft Committee Minutes

- 3.3 The Committee FURTHER RESOLVED to interrogate the Annual Performance Plan and the Quarterly Performance Reports, and to forward any further questions and requests to the Procedural Officer by Friday, 29 August 2025.
