1. Welcome and attendance

The Chairperson welcomed the members, the officials from the Department of Trade Industry and Competition (DTIC), the Provincial Treasury, the Western Cape Gambling and Racing Board (WCGRB), Adv F Jenkins from National Parliament's Legal Unit, and Adv M Khoele from the Western Cape Provincial Parliament's Legal Unit. The Chairperson informed members that they would be receiving a briefing on the National Gambling Amendment Bill [B 27D - 2018] (NGA Bill) and the processing of the Bill from 2018 to the present.

2. **Briefing by the Department of Trade, Industry and Competition**

Dr E Masotja, Deputy Director-General in the DTIC, briefed the Committee on the processing of the NGA Bill from 2018 to the present, the concerns raised by stakeholders during the processing of the B-version of the Bill and during the Mediation Committee discussions, and the amendments agreed to leading to the D-version of the Bill.

The Chairperson noted that Adv F Jenkins' presentation seemed to cover the same information detailed in the DTIC's report, and indicated that he was not required to present, but that the questions would be directed at both the DTIC and Adv Jenkins.

3. **Briefing by the Western Cape Gambling and Racing Board and Adv M Khoele**

Ms L Hartman, Legal Adviser for the WCGRB, briefed the Committee on the submissions made by the WCGRB on the NGA Bill.

Adv Khoele briefed the Committee on her legal opinion, which spoke to whether the Committee should proceed with a public participation process on the D-version of the Bill even though the NCOP had only called for the legislatures to submit voting mandates.

4. **Deliberations on the way forward for the National Gambling Amendment Bill [B 27D - 2018]**

The Chairperson requested comments from the members on the way forward for the NGA Bill.

Adv Jenkins indicated that while the legislatures were entitled to proceed with a public participation process on the Bill, there was no room for further amendments to the D-version of the Bill, as this was the Bill agreed to by the Mediation Committee, and the request was for legislatures to submit a voting mandate indicating whether they supported or did not support the Bill.

The Committee noted that Adv Khoele's legal opinion pointed out substantial and material changes in the D-version of the NGA Bill, which necessitated a call for public comments.

Following a brief discussion, and the differing opinions from the legal advisers, the Committee agreed that it would apply its mind on the way forward for the Bill and would reconvene discussions on the possible public participation process in the new year. The NCOP would be kept abreast of this development and be requested to clarify whether a date for the submission of the voting mandate had been determined yet.

5. **Consideration and adoption of the Draft Committee Documents**

The Committee considered and adopted the draft Committee Minutes of 31 October 2025, without amendments.

The Committee considered and adopted the draft Committee Report on the 2024/25 Annual Reports of the Provincial Treasury and its Entity; the Western Cape Gambling and Racing Board, without amendments.

6. **Resolutions/Actions**

The Committee RESOLVED to write to the NCOP to request clarity on the deadline for submission of the voting mandate on the NGA Bill, to inform them of the possibility that the Western Cape would be embarking on a public participation process on the D-version of the NGA Bill, and to request that this public participation process be considered when determining the deadline for the voting man date.
