1. Welcome

The Chairperson welcomed all present. The purpose of the meeting was to consider shortlists for the Western Cape Cultural Commission (WCCC) and the Western Cape Language Committee (WCLC).

2. Process to shortlist

Since October 2024, advertisements were placed in print publications in all three provincial languages, calling for nominations. The advertisements were also shared on the Western Cape Provincial Parliament's website and social media platform. The Department of Cultural Affairs and Sport was also requested to do the same. Additionally, the advertisements were included in an extensive social media campaign, via Facebook. The response was 50 nominations for the WCCC, one candidate withdrew from the nomination process, and there were 23 nominations for the WCLC.

3. Deliberation on shortlists

Committee members were given an opportunity to share their lists for the WCCC and the WCLC. The Committee first dealt with shortlisting for the WCCC. Members had access to the documentation since 6 December 2024 and therefore prepared their individual lists following thorough consideration of the nominations.

4. Resolution

The Committee resolved to shortlist the nominees who appeared at least twice across the various individual committee member lists.
