1. Welcome and apologies

The Chairperson welcomed the members, Minister, officials from the Provincial Treasury, Western Cape Gambling and Racing Board and any members of the public that were participating online. The Chairperson highlighted that the purpose of the meeting and noted and apology from Member N Constable (PA).

2. Briefing on the Third Quarterly Performance Reports for the Provincial Treasury and the Western Cape Gambling and Racing Board

The Minister, Provincial Treasury and the Western Cape Gambling and Racing Board briefed the Committee on the financial and non-financial information contained in the respective Third Quarter Performance Reports.

The Committee engaged in a question-and-answer session on the information that was presented.

3. Brief discussion on the National Gambling Amendment Bill [B 27D – 2018]

The Chairperson reminded members that the Committee had held a brief discussion on the Bill on 2 December 2025 and that the Committee had resolved to write to the NCOP Chairperson, through the Speaker of the WCPP, to request clarity on the deadline for the submission of the Voting Mandate on the Bill.

The Chairperson noted that the Committee had received a response from the NCOP in mid-January 2026 indicating that a deadline for the submission of the Voting Mandate had not yet been determined. A further recent enquiry yielded the same response.

The Chairperson further noted that the report on the Bill from the Mediation Committee had not yet been tabled at the National Assembly and discussions regarding gambling legislation and remote gambling were still being held at ministerial level. He proposed that discussions regarding the way forward for the Bill be deferred until more information was provided on the legislation.

4. Consideration and adoption of the draft Committee documents

The following documents were considered and adopted without amendments:

- The Quarterly Committee Report for October to December 2025

5. Resolutions/Actions

The Committee REQUESTED the following information from the Provincial Treasury:

- 5.1 A report on capital assets - more specifically (i) the number of laptops still to be purchased with the remaining budget, (ii) the posts the laptops were being allocated to, and (iii) the reason for the delay;
- 5.2 A report on vacancies from the 2024/25 financial year to date – more specifically (i) the number and details of posts that were filled during this period, (ii) the number and details of posts that became vacant during this period, and (iii) the number and details of the posts that will not be filled by the end of this financial year, and the reasons for the delays;
- 5.3 A supplementary report on the information requested above in 5.2 from the date of the submission of the information to the Committee to the end of the 2025/26 financial year, as soon as the information is available; and
- 5.4 A report on the number of bursaries granted by the Provincial Treasury, the value/total of the bursaries issued, and a list of bursary beneficiaries.
