**SUBJECT FOR DISCUSSION**

Mr M K Sayed: The impact of narrow majoritarian decision-making on democratic accountability, public participation and legislative oversight in the Western Cape Provincial Parliament, particularly in relation to holding the provincial executive accountable on matters affecting the residents of the Western Cape.

## FURTHER BUSINESS

### NOTICES OF MOTION (*14 May 2026*)

1. Mr B Nqgentsu: That the House debates the growing tension between urban development and heritage preservation in the City of Cape Town, particularly in the light of recent concerns raised regarding proposed high-rise developments in the historic CBD and surrounding heritage precincts.
2. Ms P Z Lekker: That the House debates the devastating impact of the recent severe weather conditions and storm damage across the Western Cape.
3. Mr F Kamfer: That the House debates the alarming rise in cases of missing children in the Western Cape.
4. Mr B Nqgentsu: That the House debates the escalating crisis of gang-related violence and murders in the Western Cape, particularly in crime hotspots across the Cape Flats.

### NOTICES OF MOTION (*7 May 2026*)

1. Mr P Johnson: That the House notes the decisive action taken by the DA-led Western Cape Education Department to protect learners during severe weather conditions in parts of the province; and further notes that 125 schools in the Eden and Central Karoo education districts have been closed due to heavy rainfall and severe weather conditions in the area, ensuring that the safety of learners and educators remains the top priority.
2. Mr D Wessels: That the House notes that it has been two years since the George building collapse on 6 May 2024, which claimed 34 lives and left 28 people injured; further notes that we remember every life lost, every family still grieving, and every survivor who continues to live with the consequences of this tragedy; further notes the Democratic Alliance's call on the National Prosecuting Authority (NPA) to take decisive prosecutorial action following the completion of the South African Police Service (SAPS) investigation into the George building collapse; and notes that this was a disaster that should never have happened and must never be allowed to happen again.
3. Mr N P Masipa: That the House welcomes the launch of the Economic Inclusion for All Bill, a transformative policy designed to replace the failed and exclusionary framework of Broad-Based Black Economic Empowerment (BBBEE). Notes that after decades, BBBEE has abjectly failed to uplift the majority of South Africans, with black unemployment rising to 35,8% and nearly 30 million black citizens still living in poverty, while an estimated R1 trillion has been shifted to a politically connected elite; commends the Economic Inclusion for All Bill for introducing a merit-based scorecard where value for money – including pricing, technical capability and innovation – accounts for 80% of the criteria, ensuring that taxpayer rands are protected and quality services are delivered; acknowledges that the remaining 20% of the scorecard focuses on genuine economic inclusion, rewarding companies for measurable social impact, such as job creation, skills development and poverty reduction, rather than mere political ties or racial categorisation; further notes that this Bill represents a fundamental shift towards justice by using poverty as the primary indicator of disadvantage, ensuring that empowerment finally reaches the unemployed and impoverished majority instead of an insider class; extends support for this bold alternative that promotes shared prosperity; and calls on all members of the Government of National

Unity to champion this move towards an economy that is inclusive, fair and based on the dignity of all South Africans.

4. Prof N Mbombo: That the House notes the launch of the draft National Rail Master Plan for public comment by the national Department of Transport as a positive step towards the restoration and modernisation of South Africa's rail network, including in the Western Cape; further notes the importance of a functional rail system in reducing transport costs, supporting economic growth and connecting residents to opportunities; and notes the need for inclusive public participation in shaping the final plan.
5. Ms B M van Minnen: That the House notes with surprise that Gayton McKenzie sent out an English invitation stating: "Let's celebrate. The Department of Sport, Arts and Culture will be hosting celebrations of the Afrikaans language" for the celebration of 100 years of Afrikaans as an official language at the War Museum; further notes the irony that a celebration for Afrikaans is being marketed primarily in English, which raises questions about the Minister's understanding of the importance of the language and the culture that underpins it; acknowledge that Afrikaans is an important language spoken by millions of South Africans from different communities and that it deserves genuine recognition and promotion; expresses concern that the Minister seems increasingly out of touch with the communities and cultures that he claims to represent; and calls on the Department of Sport, Arts and Culture to approach language and culture celebrations with more respect, seriousness and sensitivity.

## **VERDERE WERKSAAMHEDE**

### **KENNISGEWING VAN VOORSTELLE (14 Mei 2026)**

1. Mnr B Nqgentsu: Dat die Huis die toenemende spanning tussen stedelike ontwikkeling en erfenisbewaring in die Stad Kaapstad debatteer, veral in die lig van onlangse kommer wat geopper is oor voorgestelde toringgebou-ontwikkelings in die historiese SSG en omliggende erfenisgebiede.
2. Me P Z Lekker: Dat die Huis die verwoestende impak van die onlangse gure weerstoestande en stormskade in die Wes-Kaap debatteer.
3. Mnr F Kamfer: Dat die Huis die kommerwekkende toename in gevalle van vermiste kinders in die Wes-Kaap debatteer.
4. Mnr B Nqgentsu: Dat die Huis die toenemende krisis van bendeverwante geweld en moorde in die Wes-Kaap debatteer, veral in misdaadbrandpunte op die Kaapse Vlakte.

### **KENNISGEWING VAN VOORSTELLE (7 Mei 2026)**

1. Mnr P Johnson: Dat die Huis kennis neem van die beslissende optrede deur die DA-beheerde Wes-Kaapse Onderwysdepartement om leerders teen erge weerstoestande in die dele van die provinsie te beskerm; en verder kennis neem dat 125 skole in die Eden- en Sentraal-Karoo-onderwysdistrik weens swaar reën en gure weerstoestande in die gebied gesluit is, en sodoende toesien dat leerders en opvoeders se veiligheid die hoofprioriteit is.
2. Mnr D Wessels: Dat die Huis kennis neem dat dit twee jaar is sedert die gebou in George op 6 Mei 2024 ineengestort het, waartydens 34 mense dood is en 28 mense beseer is; verder kennis neem dat ons elke lewensverlies, elke familie wat nog treur, en elke slagoffer wat steeds met die nagevolge van hierdie tragedie saamleef, onthou; verder kennis neem van die Demokratiese Alliansie se beroep op die Nasionale Vervolgingsgesag (NGV) vir beslissende optrede vir vervolging ná die afhandeling van die Suid-Afrikaanse Polisiediens (SAPD) se ondersoek na die gebou-ineenstorting in George; en kennis neem dat hierdie ramp glad nie moes plaasgevind het nie en nooit weer toegelaat moet word om plaas te vind nie.
3. Mnr N P Masipa: Dat die Huis die bekendstelling van die Wetsontwerp op Ekonomiese Insluiting vir Almal (“Economic Inclusion for All Bill”) verwelkom, wat ’n transformerende beleid is wat ontwerp is om die mislukte en uitsluitende raamwerk van breedgebaseerde swart ekonomiese bemagtiging (SEB) te vervang; kennis neem dat breedgebaseerde SEB ná dekades volslae misluk het om die meerderheid Suid-Afrikaners op te hef, met swart werkloosheid wat tot 35,8% gestyg het en bykans 30 miljoen swart inwoners wat steeds in armoede leef, terwyl ’n beraamde R1 triljoen na ’n elite met politieke bande herlei is; die Wetsontwerp op Ekonomiese Insluiting vir Almal loof vir die bekendstelling van ’n telkaart wat op meriete gegrond is waar waarde vir geld – insluitende prysvasstelling, tegniese bevoegdheid en innovering – 80% van die vereistes is, wat toesien dat belastingbetalers se geld beskerm word en dienste van gehalte gelewer word; erkenning gee dat die oorblywende 20% van die telkaart op werklike ekonomiese insluiting fokus, en maatskappye vergoed vir meetbare maatskaplike impak, soos werkskepping, vaardigheidsontwikkeling en armoedevermindering, eerder as net politieke bande of rassekategorisering; verder kennis neem dat hierdie Wetsontwerp ’n fundamentele verskuiwing vir geregtigheid

verteenwoordig deur armoede as die hoofaanwyser van benadeling te gebruik, wat toesien dat die bemagtiging uiteindelik die werklose en arm meerderheid in plaas van 'n klas in die binnekring bereik; ondersteuning uitspreek vir hierdie kragtige alternatief wat gedeelde voortvarendheid bevorder; en 'n beroep doen op alle lede van die Regering van Nasionale Eenheid om voorspraak te maak vir hierdie skuif vir 'n ekonomie wat insluitend, billik en op die waardigheid van alle Suid-Afrikaners gegrond is.

4. Prof N Mbombo: Dat die Huis die bekendstelling verwelkom van die Konsep- nasionale spoormeesterplan vir openbare kommentaar deur die Departement van Vervoer omdat dit 'n positiewe stap vir die opknapping en modernisering van Suid-Afrika se spoornetwerk is, insluitende in die Wes-Kaap; verder kennis neem van die belangrikheid van 'n werkende spoorstelsel om vervoerkoste te verminder, ekonomiese groei te ondersteun en inwoners met geleenthede te verbind; en kennis neem van die behoefte aan inklusiewe openbare deelname om die finale plan te ontwikkel.
5. Me B M van Minnen: Dat die Huis met verbasing kennis neem dat Gayton McKenzie 'n Engelse uitnodiging uitgestuur het wat sê: "Let's celebrate. The Department of Sport, Arts and Culture will be hosting celebrations of the Afrikaans language" vir die viering van 100 jaar van Afrikaans as amptelike taal by die Oorlogsmuseum; verder kennis neem van die ironie dat 'n viering vir Afrikaans hoofsaaklik in Engels bemark word, wat vrae laat ontstaan oor die Minister se begrip van die belang van die taal en die kultuur wat dit onderbou; erkenning gee dat Afrikaans 'n belangrike taal is wat deur miljoene Suid-Afrikaners in verskillende gemeenskappe gepraat word en dat dit opregte erkenning en bevordering verdien; kommer uitspreek dat die Minister al hoe meer uit voeling lyk met die gemeenskappe en kulture wat hy sê hy verteenwoordig; en 'n beroep doen op die Departement van Sport, Kuns en Kultuur om taal- en kultuurvieringe met meer respek, erns en sensitiwiteit aan te pak.
