1. Welcome and attendance

The Chairperson opened the meeting and allowed Members to discuss the Matrix of Submissions for the *Communal Property Association Amendment Bill* [B 12B – 2017](NCOP)(S76).

2. Consideration of the Matrix of Submissions for the *Communal Property Association Amendment (CPA) Bill* [B 12B - 2017](NCOP)(S76) and consideration of the Negotiating Mandate on the CPA Bill

Before the consideration of the Matrix of Submissions for the *Communal Property Association Amendment (CPA) Bill* [B 12B - 2017](NCOP)(S76) and consideration of the Negotiating Mandate on the CPA Bill, the Chairperson informed the Committee that the National Council of Provinces (NCOP) had asked if the provinces would be able to submit Voting Mandates on the CPA Bill by 4 December 2018.

The Committee expressed its concerns regarding the deadline for the submission of the Voting Mandate, the lack of response to the Standing Committee's letters that were submitted to the Select Committee on 10 September, 5 November and 26 November 2018, and the lack of response to the Standing Committee's request for extensions.


3. Adoption of Draft Minutes

The Committee considered and adopted the draft Committee Minutes of 8, 29 and 30 October, and 7, 8, 13 (10h30 and 18h00), 16 and 23 (14h00 and 15h00) November 2018.

4. Resolutions/Actions

The Committee resolved to write a fourth letter to the Chairperson of the Select Committee on Land and Mineral Resources, informing him that the Standing Committee cannot proceed. The Committee will not be submitting a Voting Mandate and to express its view with its deliberations on the Negotiating Mandate on the CPA Bill, as this would be an exercise in futility in view of the Select Committee's process having overtaken the Western Cape's process; and that the Standing Committee, accordingly, is not able to accede to the Select Committee's request for a Voting Mandate to be submitted in anticipation of the House sitting on 4 December 2018.
