### COMMITTEE REPORT

**The Standing Committee on Police Oversight, Community Safety, Cultural Affairs and Sport, having considered a long list of candidates for appointment for the new term of the Council of Heritage Western Cape, dated 23 September 2025, reports as follows:**

1. The current term of the Council of Heritage Western Cape expires on 31 October 2025.
2. In accordance with regulation 2(3) made under the National Heritage Resources Act, 1999 (Act 25 of 1999), the provincial Minister of Cultural Affairs and Sport referred the nominations to the Standing Committee on Police Oversight, Community Safety, Cultural Affairs and Sport. In accordance with regulation 2(4), the Committee compiled a shortlist and submitted it to the provincial Minister.
3. Heritage Western Cape, through the Department of Cultural Affairs and Sport, briefed the Committee on Heritage Western Cape, its role, legal framework, its membership requirements, any prohibitions of appointment, as well as several matters pertaining to the effective functioning of the public entity and its subcommittees. The briefing was held on 26 August 2025.
4. The Committee deliberated on the nominations and drafted a shortlist considering the knowledge and qualifications of the nominees. The Committee also considered the demographics, cultural representivity and suitability of the nominees for heritage resource management.
5. The Committee further considered the requirements contained in subregulations (6) and (7) of the National Heritage Resources Act, 1999 (Act 25 of 1999). The Committee resolved to submit its shortlist of candidates to the provincial Minister of Cultural Affairs and Sport for consideration for appointment.

### KOMITEEVERSLAG

**Die Staande Komitee oor Polisietoesig, Gemeenskapsveiligheid, Kultuursake en Sport,** nadat 'n lang lys kandidate vir aanstelling vir die nuwe termyn van die Raad van Erfenis Wes-Kaap oorweeg is, gedateer 23 September 2025, doen soos volg verslag:

1. Die huidige termyn van die Raad van Erfenis Wes-Kaap verstryk op 31 Oktober 2025.
2. Ooreenkomstig regulasie 2(3) gemaak kragtens die Wet op Nasionale Erfenishulpbronne, 1999 (Wet 25 van 1999), het die provinsiale Minister van Kultuursake en Sport die benoemings na die Staande Komitee oor Polisietoesig, Gemeenskapsveiligheid, Kultuursake en Sport verwys. Ooreenkomstig regulasie 2(4) het die Komitee 'n kortlys saamgestel en dit aan die provinsiale Minister voorgelê.
3. Erfenis Wes-Kaap, deur middel van die Departement van Kultuursake en Sport, het die Komitee ingelig oor Erfenis Wes-Kaap, sy rol, wetlike raamwerk, sy vereistes vir lidmaatskap, enige verbod op aanstelling, sowel as verskeie aangeleenthede wat met die doeltreffende funksionering van die staatsentiteit en sy subkomitees verband hou. Die inligtingsvergadering is op 26 Augustus 2025 gehou.
4. Die Komitee het beraadsblaag oor die benoemings en 'n kortlys saamgestel met oorweging van die benoemdes se kennis en kwalifikasies. Die Komitee het ook die demografie, kultuurvertegenwoordiging en geskiktheid van die benoemdes vir die bestuur van erfenis-hulpbronne oorweeg.
5. Die Komitee het verder die vereistes oorweeg kragtens subregulasie (6) en (7) van die Wet op Nasionale Erfenishulpbronne, 1999 (Wet 25 van 1999). Die Komitee het besluit om sy kortlys van kandidate aan die provinsiale Minister van Kultuursake en Sport voor te lê om vir aanstelling oorweeg te word.
