COMMITTEE REPORT

Report of the Standing Committee on Police Oversight, Community Safety, Cultural Affairs and Sport on the recommendations for the appointment of candidates to the Governing Board of the Western Cape Liquor Authority, dated 10 March 2026, as follows:

1. The Governing Board of the Western Cape Liquor Authority (the Board) required membership for two vacancies, in order to comply with section 3(1)(a) of the Western Cape Liquor Act, 2008 (Act 4 of 2008).
2. Section 3(3) of the Western Cape Liquor Act, 2008 (Act 4 of 2008) stipulates that “the standing committee must make the recommendations referred to in subsection (1) after evaluating all candidates as to their suitability for appointment”.
3. The Committee, having received a list of candidates from the Minister of Police Oversight and Community Safety in the Western Cape, proceeded to interview 11 candidates on 9 and 10 March 2026.
4. Following deliberations, the Committee resolved to submit the top four highest-scoring interviewees to the provincial Minister of Police Oversight and Community Safety to consider for appointment to the Governing Board of the Western Cape Liquor Authority.

KOMITEEVERSLAG

Verslag van die Staande Komitee oor Polisietoesig, Gemeenskapsveiligheid, Kultuursake en Sport oor die aanbevelings vir aanstelling van kandidate in die Bestuursraad van die Wes-Kaapse Drankowerheid, gedateer 10 Maart 2026, soos volg:

1. Die Bestuursraad van die Wes-Kaapse Drankowerheid (die Raad) vereis lidmaatskap vir twee vakatures om te voldoen aan artikel 3(1)(a) van die Wes-Kaapse Drankwet, 2008 (Wet 4 van 2008).
2. Artikel 3(3) van die Wes-Kaapse Drankwet, 2008 (Wet 4 van 2008), bepaal dat “Die staande komitee moet die aanbevelings bedoel in subartikel (1) doen ná die evaluering van al die kandidate met betrekking tot hulle geskiktheid vir aanstelling”.
3. Nadat die Komitee ’n lys kandidate van die Minister van Polisie-toesig en Gemeenskapsveiligheid in die Wes-Kaap ontvang het, het hy tussen 9 en 10 Maart 2026 onderhoude met 11 kandidate gevoer.
4. Ná beraadslaging het die Komitee besluit om die vier topkandidate met die hoogste puntetellings vir aanstelling in die Bestuursraad van die Wes-Kaapse Drankowerheid aan die Minister van Polisie-toesig en Gemeenskapsveiligheid vir oorweging voor te lê.
