COMMITTEE REPORT

Report of the Standing Committee on Finance, Economic Opportunities and Tourism (the Committee) on the recommendations for the appointment of candidates to the Western Cape Gambling and Racing Board, dated 29 February 2024, as follows:

1. The matter of vacancies on the Western Cape Gambling and Racing Board (the Board) was referred to the Committee on 24 January 2024 by the Office of the Speaker.

- 2. Section 3(1) of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996, as amended) (the Act) stipulates: "The Board shall consist of seven members, appointed on a part-time basis, by the Executive Council in accordance with the prescribed procedure, which shall provide for public participation in the nomination of candidates for appointment; provided that the standing committee of the Provincial Legislature responsible for this Act shall evaluate all candidates as to their suitability for appointment."
- 3. On 23 February 2024, the Provincial Treasury briefed the Committee on the process leading to the shortlisting of candidates. The Provincial Treasury informed the Committee that there were four upcoming vacancies that needed to be filled. The Committee was provided with a list of 14 candidates to evaluate.
- 4. Following the briefings by the Provincial Treasury and Mazars Forensic Services, the service provider that conducted the probity assessments, the Committee resolved to evaluate 12 of the 14 candidates. The Committee also resolved to evaluate the candidates through an interview process.
- 5. In accordance with regulation 4(3) of the Western Cape Gambling and Racing Regulations, 1996 (PN 239 of 1996), the Committee "... shall, within seven days from receiving the documentation ... submit a final short list of not less that fifteen names or, in respect of any vacancy occurring on the Board, of not less than three names, together with the comprehensive list of all applicants to the responsible Minister for submission for consideration to the Executive Council".
- 6. The Committee, having interviewed the 12 candidates on 29 February 2024, recommends that nine of the candidates were found to be suitable to serve on the Board. The nine candidates, ranked in order, are as follows:
 - (1) Ms L Venter
 - (2) Mr A Chetty
 - (3) Mr C Bassuday
 - (4) Mr T Arendse
 - (5) Ms C Fani
 - (6) Ms C Horton
 - (7) Mr D Lakay
 - (8) Mr D Fredericks
 - (9) Mr J Jacobs
- 7. The Committee further recommends that Ms C Fani's term be extended in accordance with section 6 of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996).
- 8. The Committee also submits Members' scoresheets along with this Report. The scoresheets are attached as an annexure.
