## **COMMITTEE REPORT**

The Standing Committee on Community Safety, Cultural Affairs and Sport, having deliberated on the 2021/22 Policing Needs and Priorities Report, dated 3 March 2023, reports as follows:

1. The Committee, having received the referral of the 2021/22 Policing Needs and Priorities Report in terms of section 23(2) of the Western Cape Community Safety Act, 2013 (Act 3 of 2013), proceeded to discuss the Report.
2. The Committee, in terms of section 23(3) of the Act, considered the Report.
3. The Committee, in terms of section 23(4) of the Act, afforded the Provincial Police Commissioner of the South African Police Service (SAPS) and the Executive Head of Municipal Policing the opportunity to give input on the Report.
