- 1. Report of the Parliamentary Oversight Committee on the Western Cape Provincial Parliament's Fourth Quarter Performance (financial and non-financial) 2025, dated 5 June 2025, as follows:**

The Parliamentary Oversight Committee convened on 5 June 2025 and concluded its deliberations on the Western Cape Provincial Parliament's Fourth Quarter Performance (financial and non-financial), referred to it in accordance with Standing Rule 89(1).

In terms of section 37(6) and 66(2) of the FMPPLA, the Western Cape Provincial Parliament reported to the Committee that no instructions were issued for the period under review.

1. Introduction

The Parliamentary Oversight Committee (POC) derives its authority from the Financial Management of Parliament and Provincial Legislatures Act, 2009 (Act 10 of 2009) (FMPPLA), which establishes the Committee as the primary oversight mechanism for the Western Cape Provincial Parliament (WCPP). The POC's core mandate encompasses comprehensive oversight of Parliament's financial management, including:

- (a) reviewing executive instructions issued under sections 37(5) and 66 of the FMPPLA;
- (b) examining the annual report submitted in terms of section 60; and
- (c) performing additional functions as specified in the Act or Parliamentary Rules.

The Committee exercises constitutional powers under sections 56 and 69 of the Constitution, enabling it to summon officials, including the Accounting Officer, to account before it.

In discharging its responsibilities, the POC systematically reviews all quarterly, mid-year, and annual reports of the WCPP, along with audit findings from the Auditor-General of South Africa (AGSA).

The Committee also considers any other financial statements or reports referred by the House.

Beyond financial oversight, the POC is mandated to actively facilitate public participation in legislative processes, ensuring its operations remain transparent and accessible.

The Committee maintains rigorous oversight of corporate governance practices within the WCPP, promoting accountability and good governance, while regularly reporting its findings and recommendations to the House.

3. Oversight activities

During the 2024/25 financial year, the Parliamentary Oversight Committee (POC) conducted oversight through quarterly performance reviews, financial scrutiny, and public engagement.

In August 2024, the Committee received a briefing on the 2024/25 Annual Performance Plan and the Fourth Quarterly Performance Report, assessing both financial and non-financial outcomes.

This was followed in November 2024 by a review of the Second Quarterly Performance Report, and in February 2025, the Committee evaluated the Third Quarterly Performance Report to ensure accountability in the WCPP's operations.

Financial oversight remained a priority, with the Committee deliberating on the 2023/24 Annual Report in October 2024, including an analysis of audit outcomes from the Auditor-General of South Africa (AGSA). Additionally, the Committee engaged with the Western Cape Adjustments Appropriation Bill [B 2–2024] in November 2024 focusing on budgetary adjustments under Vote 2 (WCPP) and later held a public hearing on the Western Cape Appropriation Bill, 2025, in April 2025.

To uphold transparency, the POC facilitated public participation in discussions on the Annual Report and money bills.

Key resolutions included requests for detailed reports on public education outreach by district, exploration of inter-legislative partnerships (such as with Gauteng and KwaZulu-Natal legislatures), and a review of social media engagement strategies to enhance public interaction. The Committee also scrutinised security protocols for parliamentary events, seeking clarity on funding arrangements with the South African Police Service (SAPS). These efforts were aimed at strengthening governance, improving service delivery, and ensuring the WCPP's compliance with its constitutional mandate.

4. Legislation

In the 2024/25 financial year, the Committee dealt with the following provincial legislation:

- 4.1 Vote 2: WCPP in the Western Cape Adjustments Appropriation Bill [B 2–2024]; and
- 4.2 Vote 2: WCPP in the Western Cape Appropriation Bill [B 2–2025].

5. Facilitation of public involvement and participation

In fulfilment of its constitutional obligation to promote public participation in legislative processes, the Committee conducted three public hearings, including one dedicated session for consideration of the Annual Report, which was widely advertised on multiple platforms. The other two hearings focused on critical financial legislation: the Western Cape Adjustments Appropriation Bill [B 2–2024] and the Western Cape Appropriation Bill [B 2–2025], both pertaining to Vote 2: Western Cape Provincial Parliament. To enhance accessibility, the Committee employed hybrid meeting formats (both physical and virtual attendance options).

While these efforts demonstrated the Committee's commitment to participatory democracy, attendance remained limited, prompting the POC to resolve to strengthen its public outreach strategies in the coming financial year through targeted community engagements and improved communication channels.

6. Financial particulars

The actual expenditure for the 2024/25 financial year was R18 738 against an adjusted budget allocation of R16 891 resulting in an overspending of R1 847.

3. ANNUAL ACTIVITY REPORT OF THE STANDING COMMITTEE ON POLICE OVERSIGHT, COMMUNITY SAFETY, AND CULTURAL AFFAIRS AND SPORT FOR THE PERIOD 1 APRIL 2024 TO 31 MARCH 2025

The Strategic Objectives of the WCPP linked to the Speaker's priorities that have an impact on committees are as follows:

- Priority 1: Building a credible WCPP; and
- Priority 3: Strengthening the core business.

The Standing Committee on Police Oversight and Community Safety, Cultural Affairs and Sport, conducts oversight over multiple portfolios. The Committee's membership is different for each of the two main portfolios, that is, matters related to Community Safety and matters related to Cultural Affairs and Sport.

Towards the end of the sixth parliament, the Committee conducted an oversight visit. Due to the 2024 national elections, the seventh parliamentary term commenced after the elections. The new Committee was constituted on 4 July 2024.

The Standing Committee on Police Oversight, Community Safety, and Cultural Affairs and Sport, reports on its 2024/25 annual activities, as follows:

1. Introduction

The mandate of the Committee is to:

- a. maintain oversight over the Executive and other stakeholders responsible for police oversight and community safety, and cultural affairs and sport, in the province.
- b. hold the Department of Police Oversight and Community Safety, the Western Cape Police Ombudsman, the Western Cape Liquor Authority, and the South African Police Service accountable and to also hold accountable the Department of Cultural Affairs and Sport, and its Entities (Western Cape Language Committee, Western Cape Cultural Commission and Heritage Western Cape).
- c. consider and report on legislation and other matters referred to it by the Speaker.
- d. monitor the implementation of legislation.

In the fulfilment of its mandate, the Committee:

- a. facilitated public participation in the legislative and other processes of the Committee.
- b. conducted its business in a fair, open and transparent manner.
- c. promoted cooperative governance.
- d. reported regularly to the House.

The Committee deals with two distinct portfolios. The report will detail the activities per portfolio.

2. Reporting departments, entities, and stakeholders

- 2.1. The Department of Cultural Affairs and Sport, and its entities (Western Cape Language Committee, Western Cape Cultural Commission and Heritage Western Cape).
- 2.2. The Department of Police Oversight and Community Safety and its entities (Western Cape Police Ombudsman and Western Cape Liquor Authority).
- 2.3. The South African Police Service and the City of Cape Town's Safety and Security Directorate are two stakeholders which the Committee regularly engages with as part of safety and policing matters in the Western Cape.

3. Overview of activities

During the 2024/25 financial year, the Standing Committee on Police Oversight, Community Safety, Cultural Affairs and Sport conducted an oversight visit to the South African Police Service's Forensic Science Laboratory in Platteklouf. Following this visit, the SAPS briefed the Committee on the spike of gang-related violence across the Cape Flats, at that time. This was the last activity by the Committee of the sixth parliamentary term.

The newly formed Committee elected its chairperson on 4 July 2024. In August 2024, the Department of Police Oversight and Community Safety, as well as the Department of Cultural Affairs and Sport, briefed the Committee on their respective 2024/25 Annual Performance Plans. These briefings also served as introductory engagements with the two Departments.

The Committee conducted its cyclical oversight over both Departments and the respective entities, in respect of the 2023/24 Annual Reports, the Western Cape Adjustment Appropriation for 2024 and the 2025/26 Western Cape Appropriation.

Regarding the Police Oversight and Community Safety component, the Committee resolved not to extend the tenure of the Western Cape Liquor Authority Governing Board

chairperson. The reason for this was that the Committee had received a request to extend the term of the Governing Board chairperson, a day prior to the expiration of the term of office. The WCPP legal advisory unit also gave input that helped shape the Committee's resolution not to extend the term of office. The Department of Police Oversight and the Western Cape Liquor Authority were given the opportunity to explain the reason for the deviation from the regulations requiring that the request to the Committee be submitted six months prior to the expiration of the chairperson's term of office.

The Committee conducted an oversight visit to the Khayelitsha SAPS. The visit included briefings from representatives of the Khayelitsha, Lingulethu West and Mfuleni police stations. The Makhaza SAPS had only opened a few months prior to the visit and was not included in the visit.

The Committee also dealt with the Policing Needs and Priorities report, having invited the Department of Police Oversight and Community Safety to present its findings. The Committee concluded its deliberations with no further contributions from SAPS and the Head of Municipal Policing to the input that these stakeholders previously submitted to the Department.

In terms of the Cultural Affairs and Sport portfolio, the Committee extensively advertised calls for nominations for the Western Cape Language Committee and the Western Cape Cultural Commission memberships. Both entities required members for a new term of office. The Department of Cultural Affairs and Sport included the criteria for these entity memberships in its APP presentation. The Committee, after thorough and careful consideration, decided on its final shortlists for both entities, from which the Minister for this portfolio would have to appoint new members for the entities.

The Western Cape Public Library Services Bill [B 1–2025] was referred to the Committee in early 2025. Following the 21-day publication in the Western Cape Provincial Gazette, the Department of Cultural Affairs and Sport briefed the Committee on the Bill. The Committee resolved to advertise its public hearing process across various platforms, including print media, by informing stakeholders, using public libraries as nodal points for access to the virtual public hearing, and social media advertising and promotion, via the WCPP's services. The public hearings and conclusion of the Bill were scheduled for the first quarter of 2025/26.

During the visit week to Beaufort West, the Committee led deliberations at the Merweville Library and the Beaufort West SAPS.

8. Financial particulars

The Standing Committee spent R121 199,87 in the financial year. The budget was spent on advertisements for the annual report meetings, the various Appropriation and Adjustments Appropriation Bills, as well as catering for in-person meetings. The Committee also paid to advertise for calls for nominations to the Western Cape Cultural Commission and the Western Cape Language Committee.
