4. Oversight activities

- 4.1 The Committee started the first quarter with a briefing by the Department regarding the progress on the section 139(5) intervention and the Financial Recovery Plan at Beaufort West and the section 154 Support Plan at the Kannaland and Laingsburg municipalities. The Committee was also briefed on the successes and challenges of the Community Development Workers Programme and the Indigent Policy at municipalities. The Auditor-General then briefed the Committee on the audit outcomes (MFMA 2021/22) with specific reference to the audit outcomes of the municipalities in the Western Cape, and particularly the underperforming municipalities.
- 4.2 The Committee started the quarter with briefings by the Department of Local Government and the Provincial Treasury on the audit outcomes of the municipalities in the Western Cape for the 2021/22 financial year with specific reference to the corrective measures and support envisaged at the Kannaland, Beaufort West and Laingsburg municipalities, followed by a discussion on the challenges and possible interventions to improve audit outcomes in future. The Committee had a meeting to finalise the resolutions on the corrective measures and attended the NCOP visit week.
- 4.3 During the third quarter the Committee deliberated on the Annual Report of the Department of Local Government for the 2022/23 financial year. The Committee concluded the quarter with the deliberation on Vote 14: Local Government in the Schedule to the Western Cape Adjustments Appropriation Bill of 2023 and the adoption of the Committee Report on Vote 14: Local Government.
- 4.4 The fourth quarter commenced with a briefing by the Department of Cooperative Governance on the Independent Municipal Demarcation Authority Bill [B 14B– 2022] (NCOP) and a briefing by the Department of Local Government on their comments on the Independent Municipal Authority Demarcation Bill. After considering the comments on the Independent Municipal Authority Demarcation Bill, the Committee adopted the negotiating mandate on the Independent Municipal Authority Demarcation Bill. The Committee deliberated on Vote 14: Local

Government in the Schedule to the Western Cape Appropriation Bill of 2024 after which they considered and adopted the Committee Report on Vote 14: Local Government.

5. **Oversight activities**

- 5.1 The first quarter started with the Department of Transport and Public Works that briefed the Committee on the upcoming Easter Road Safety Campaign. It was followed by a briefing from the Department of Transport on the National Road Traffic Amendment Bill [B 7B–2020] and the National Land Transport Amendment Bill [B 7F–2016] which was referred to the Committee. The Committee facilitated two public hearings on the two bills including the Economic Regulation of Transport Bill [B 1B-2020] (NCOP).
- 5.2 During the second quarter the Committee were briefed by Minister Mackenzie and the Department of Mobility on its Annual Performance Plan 2023/24 and its First Quarterly Performance Report and Expenditure Report. The Committee also received a briefing by the Department on its written comments on the Economic Regulation of Transport Bill [B 1B-2020] (NCOP), the National Road Traffic Amendment Bill [B 7B-2020] and the National Land Transport Amendment Bill [B 7F-2016], and adopted its negotiating mandate reports on the Economic Regulation of Transport Bill [B 1B-2020] (NCOP), the National Road Traffic Amendment Bill [B 7B–2020] and the National Land Transport Amendment Bill [B 7F–2016]. The Committee concluded the second quarter with an oversight visit to the Cape Winelands Airport.
- 5.3 During the third quarter the Committee deliberated on the annual reports of the Department of Transport and Public Works (Vote 10) and Government Motor

Transport for the 2022/23 financial year. The Committee also deliberated on Vote 8: Mobility in the Schedule to the Western Cape Adjustments Appropriation Bill of 2023 and adopted the Committee Report on Vote 8: Mobility in the Schedule to the Western Cape Appropriation Bill of 2023. The Committee was briefed by the national Department of Transport on the Transport Appeal Tribunal Amendment Bill [B 8B–2020] and considered and adopted the final mandate reports on the National Road Traffic Amendment Bill [B 7B–2020], the National Land Transport Amendment Bill [B 7F–2016] and the Economic Regulation of Transport Bill [B 1D–2020].

5.4 The fourth quarter commenced with a briefing by the national Department of Transport on the Railway Safety Bill [B 7B–2021] and briefings by the Department of Mobility on the Transport Appeal Tribunal Amendment Bill [B 8B–2020] and the Railway Safety Bill [B 7B–2021]. The Committee considered the comments by the Department of Transport on the comments of the Western Cape Government on the Transport Appeal Tribunal Amendment Bill [B 8B–2020] and the Railway Safety Bill [B 7B–2021]. The Committee adopted the negotiating mandates on the bills and concluded the quarter with the consideration of Vote 8: Mobility in the Schedule to the Western Cape Appropriation Bill of 2024 and the adoption of the Committee Report on Vote 8: Mobility in the Schedule to the Western Cape Appropriation Bill of 2024.
