- 1.1 A list of schools that are receiving a new school hall during the 2016/17 financial year.
- 1.2 A list of schools that are receiving mobile classrooms during the 2016/17 financial year.
- 1.3 A written report as to the process of moving Early Childhood Development (ECD) practitioners to Grade R teachers. The report should contain the reasons for the delay and the proposed time frame to deal with the conversion of the ECD practitioners.

2. Concern

The Committee raised its concern that the explanation provided by Provincial Treasury to the Budget Committee on 24 November 2016, with regard to the Western Cape

Education Department's budget in Programme 1: Administration, R1,420 million, and in Programme 2: Public Ordinary School Education, R1,724 million, was incorrect.
