5.2.6 Committee authorises the legal, research and/or procedural support from the relevant WCPP divisions to be able to request, through its Chairperson on the Committee's behalf, documentation, presentations, briefing material and input from different Parliaments across the world, government departments and entities, think tanks, NGO's and any other relevant stakeholders who have already implemented a Bill on such a matter and/or have completed relevant research on the matter.
