## **1. Welcome**

The Committee Chairperson welcomed all to the meeting and allowed for brief introductions. He thereafter set the context for proceedings which was to deliberate on (a) the 2018/19 Annual Report of the Western Cape Liquor Authority (WCLA), and (b) the 2018/19 Annual Report of the Department of Community Safety (the Department).

## **2. Western Cape Liquor Authority**

The Chairperson tabled the 2018/19 Annual Report of the Western Cape Liquor Authority. The Acting Chief Executive Officer, Mr S George, provided introductory comments. The Chairperson of the WCLA's Governing Board, Adv T Sidaki, provided introductory comments. The Committee deliberated on the Report, posing questions to the WCLA and the Department, which were duly answered.

## **3. Public input on the Liquor Authority's Annual Report**

The Chairperson allowed for input by members of the public there were no oral or written submissions.

The Chairperson thanked Western Cape Liquor Authority officials and they were excused from the meeting.

#### **4. Department of Community Safety**

The Chairperson tabled the 2018/19 Annual Report of the Department of Community Safety. The Minister, Mr A Fritz, and the Head of Department, Mr G Morris, provided brief introductory comments. The Committee deliberated on the Report, posing questions to the Department, which were duly answered.

#### **5. Public Input on the Department's Annual Report**

The Chairperson allowed for input by members of the public there were no oral submissions. Mr M Mbiko provided a written submissions prior to the meeting.

The Chairperson thanked the Minister and the Department. They we thereafter excused from the meeting.

#### **6. Requests for information**

The Committee requested that the Western Cape Liquor Authority provide:

- 6.1 A copy of the Western Cape Liquor Authority's Employment Equity Plan.
- 6.2 A list of the names of persons on the Liquor Licensing Tribunal, and those of the Section 24 Committee. Include the structure of the Section 24 Committee, the appointment process, and its functions.
- 6.3 The Western Cape Liquor Authority visited different communities to engage and share relevant information including the role of communities in the liquor licensing application process, creating awareness on the negative consequences of liquor abuse, and to answer questions for clarity. Provide a list of the areas visited.
- 6.4 Copies of the Western Cape alcohol-related harms reduction policy.

The Committee requested that the Department of Community Safety provide:

- 6.5 The Department reported on its partnership with the National Secretariat of Police to compile a review of the 150 police stations in the Western Cape. Provide a copy of the findings of the review.
- 6.6 A copy of the Safer Western Cape 2018 Conference Report, as well as an update on the implementation of the resolutions listed in the Report.
- 6.7 A breakdown of the unemployment statistics and child headed households of the ten stations in the top 30 murder stations.
- 6.8 A list of the membership of the Western Cape Provincial Safety Advisory Committee.
- 6.9 The number of graduate and Premier's Advancement of Youth interns who are given full time employment opportunities in the Department, during 2018/19.

- 6.10 A copy of the analysis of sick leave applications for the 2018/19 financial year. The list should not include the names of the applicants.
- 6.11 A list of the Neighbourhood Watches that were not accredited and have not receive funding, and the reasons for the non-funding.

### **7. Recommendations**

The Committee recommended that the Department of Committee Safety avail all reports requested by the Standing Committee, on the Department's website, where access of such reports to the public is not prohibited by legislation.
