- (1) With reference to the outbreak of listeriosis, how is his Department ensuring that children at early childhood development centres (ECD centres) are safeguarded against the bacteria and that children do not consume food items that have been identified as contaminated;
- (2) whether his Department communicated with teachers and parents at ECD centres about listeriosis; if not, why not; if so, what are the relevant details;
- (3) whether any cases of infections at ECD centres in the province have been reported; if so, (a) where, (b) how many and (c) how is his Department addressing them?

With reference to the outbreak of listeriosis, whether her Department communicated with schools in the Cederberg Municipality about the dangers posed by the listeriosis outbreak and how to prevent infections; if not, why not; if so, what are the relevant details?

- (1) Whether her Department has plans to close the Lamberts Bay Primary School; if so, what are the relevant details;
- (2) whether her Department has plans to amalgamate the Lamberts Bay Primary School with another school; if not, why not; if so, (a) with which school and (b) when will this happen;
- (3) whether there are plans to build a high school at Lamberts Bay; if not, why not; if so, what are the relevant details?

4. Mr N E Hinana to ask Mr D A C Grant, Minister of Transport and Public Works:

- How many incidents were reported of ambushes by thieves who attacked vehicles by creating obstacles on roads and then stoning, stealing or hijacking vehicles on the Western Cape's N2 highway, and its off-ramps and on-ramps, in (a) 2015/16, (b) 2016/17 and (c) 2017/18;
- (2) whether any proactive measures to combat this have been taken by (a) his Department, (b) the City of Cape Town and (c) the South African Police Service; if not, why not; if so, what are the relevant details?

- (1) Whether there is an environmental policy and a management plan for Gouritz River; if so, (a) when was (i) the policy and (ii) the management plan approved and (b) who are the role-players;
- (2) whether the Gouritzmond conservation trust comprises part of the management; if not, why not; if so, what are the relevant details;
- (3) what legislation and control measures are in place to conserve the vlei and nature areas?

7. Mr R D Mackenzie to ask Ms N Mbombo, Minister of Health:

With reference to the recent fire at the Mitchells Plain Hospital:

- (1) whether she has received any reports relating to the fire; if so, what are the relevant details;

- (3) whether a contractor has been appointed to refurbish the Emergency Centre at the hospital; if not, why not; if so, what are the relevant details;
- (4) whether her Department plans to fast-track the refurbishment of the Emergency Centre; if not, why not; if so, what are the relevant details;
- (5) how is her Department ensuring that service delivery at the Emergency Centre is not hampered and what additional support is her Department giving to the hospital to ensure that neither the appointment of a contractor nor the refurbishment process is delayed?

8. Ms M M Wenger to ask Mr D Plato, Minister of Community Safety:

- (1) What is the average police-to-population ratio for the (a) Cape Town metropolitan area and (b) Western Cape;
- (2) whether these ratios include (a) student constables and (b) support staff; if so, what are the ratios, excluding 2(a) and (b);
- (3) what is the police-to-population ratio for each police station in the Cape Town metropolitan area;
- (4) what is the detective-to-population ratio for each police station in the Cape Town metropolitan area?

Given the recent increase in learner numbers, whether she received any additional funding for (a) more primary schools, (b) more high schools and (c) the appointment of more teachers at schools in Mitchells Plain; if not, why not; if so, what are the relevant details?
