1. Mr D G Mitchell to ask Mr A W Bredell, Minister of Local Government, Environmental Affairs and Development Planning:

With reference to the skills centre in Beaufort West:

- (1) Whether the municipal erf (land) is zoned for the building of a skills centre; if not, why not; if so, what are the relevant details;
- (2) whether a copy of the completed building plans of the skills centre as submitted to the Beaufort West Municipality can be made available; if not, why not; if so, what are the relevant details;
- (3) whether the municipal erf was surrendered by the municipality for the purpose of building a skills centre; if so;
- (4) whether a copy of the council minutes where such a decision was taken be made available; if not, why not; if so, what are the relevant details;
- (5) (a) who funded the cost of the building the skills centre, (b) what was the total cost allocated for the building of the skills centre, (c) what are the names of the (i) contractor and (ii) subcontractor and/or any other contractor who was commissioned to build the said skill centre;
- (6) whether the building of the skills centre is complete; if not, why not; if so, when was the skills centre handed over to the community?

2. Ms N D Nkondlo to ask Mr A W Bredell, Minister of Local Government, Environmental Affairs and Development Planning:

- (a) How much was spent on the establishment of desalination plants as a water augmentation response to Day Zero and the drought in the province, (b) how many desalination plants have been established, (c) what is the (i) cost breakdown and (ii) status of each plant, (d) what was the envisaged volumes of water to be produced by this process, and (e) what has ultimately been received from each desalination plant to date;
- (2) whether some of the desalination plants have gotten into legal disputes; if so,(a) what are the relevant details per plant, (b) what is cost of litigation to date and(c) provide details per plant of the (i) status of such processes and (ii) cost to date of such litigation or decommissioning;
- (3) whether some of the desalination plants are being decommissioned; if so, (a) why,(b) what is the status of the process and (c) what is the cost to date of the decommissioning;
- (4) (a) what are the details of the service providers that were commissioned to establish these desalination plants and (b) how much did each service provider get from the contract?

(a) What is the number of COVID-19 tests that have been conducted in the province for the period (i) 1 April to 31 May 2020 and (ii) 1 June to 20 July 2020, (b) what is the number of contacts that have been traced between 1 June and 20 July 2020, (c) what circumstances have led to the slow transmission of COVID-19 in the province between June and July 2020 and (d) what are the reasons for the high COVID-19 fatalities in the Western Cape as compared to other provinces with higher infections?

- (2) whether his Department provided any assistance to the residents in informal settlements who were affected by the storms; if not, why not; if so, what are the relevant details;
- (3) whether he visited any of the affected informal settlements; if not, why not; if so, what are the relevant details?

- (5) whether the City of Cape Town or any other municipality in the province has a policy on urban agriculture; if not, why not; if so, what are the relevant details;
- (6) whether his Department has a list of municipal-owned land across all municipalities that is being leased to farmers and or community food gardens; if not, why not; if so, what are the relevant details;
- (7) what is the (a) total extent in hectares of private agricultural land in the province and(b) percentage of such land owned by (i) black South Africans (that is Africans, coloureds and Indians), (ii) white South Africans and (iii) foreign nationals?
