COMMITTEE REPORT

The Standing Committee on Community Safety, Cultural Affairs and Sport, having deliberated on the 2019/20 Policing Needs and Priorities Report, dated 18 November 2020, reports as follows:

1. The Committee, having received the referral of the 2019/20 Policing Needs and Priorities Report in terms of section 23(2) of the Western Cape Community Safety Act, 2013 (Act 3 of 2013), proceeded to discuss the Report.
2. The Committee afforded the Minister of Community Safety and the Department of Community Safety the opportunity to provide an overview of the key findings of the Report.
3. The Committee afforded the Provincial Police Commissioner of the South African Police Service (SAPS) and the Executive Head of Municipal Policing the opportunity to give input on the Report in accordance with section 23(4) of the Act.

4. The Committee, having considered the input given by the Provincial Police Commissioner of the South African Police Service (SAPS) and the Executive Head of Municipal Policing, recommends that:
 - 4.1. The line of reporting of the Forensic Laboratory Services of the South African Police Service (SAPS) be directed to a provincial SAPS level and not the national SAPS level.
 - 4.2. The Department of Community Safety conduct a study to determine what the effects would be of moving the forensic services from the South African Police Service to a provincial government department level, such as the Department of Health, or to the National Laboratory Services. The purpose of such a transition would be to gain provincial oversight over forensic services.

KOMITEEVERSLAG

Die Staande Komitee oor Gemeenskapsveiligheid, Kultuursake en Sport, nadat beraadslaag is oor die Verslag oor Polisiëringsbehoeftes en -prioriteite vir 2019/20 ("2019/20 Policing Needs and Priorities Report"), gedateer 18 November 2020, doen soos volg verslag:

1. Die Komitee, nadat die verwysing van die Verslag oor Polisiëringsbehoeftes en -prioriteite vir 2019/20 ("2019/20 Policing Needs and Priorities Report") ingevolge artikel 23(2) van die Wes-Kaapse Wet op Gemeenskapsveiligheid, 2013 (Wet 3 van 2013) ontvang is, het die verslag vervolgens bespreek.
2. Die Komitee het die Minister van Gemeenskapsveiligheid en die Departement van Gemeenskapsveiligheid die geleentheid gegun om 'n oorsig van die sleutelbevindings van die verslag te gee.

3. Die Komitee het ooreenkomstig artikel 23(4) van die Wet aan die Provinsiale Polisiekommissaris van die Suid-Afrikaanse Polisie diens (SAPD) en aan die Uitvoerende Hoof van Munisipale Polisie diens die geleentheid gegee om insette oor die verslag te lewer.
4. Die Komitee het, nadat die insette van die Provinsiale Polisiekommissaris van die Suid-Afrikaanse Polisie diens (SAPD) en van die Uitvoerende Hoof van Munisipale Polisie diens oorweeg is, aanbeveel dat:
 - 4.1. Die verslagdoeningslyn van die Forensiese Laboratorium diens van die Suid-Afrikaanse Polisie diens (SAPD) op 'n provinsiale SAPD-vlak gerig moet wees en nie op 'n nasionale SAPD-vlak nie.
 - 4.2. Die Departement van Gemeenskapsveiligheid 'n studie uitvoer om te bepaal wat die gevolge sou wees as die forensiese diens van die Suid-Afrikaanse Polisie diens na die vlak van 'n provinsiale staatsdepartement, soos die Departement van Gesondheid, of na die Nasionale Laboratorium diens verskuif sou word. Die doel van sodanige oorgang sou wees om provinsiale toesig oor forensiese dienste te verkry.
