### COMMITTEE REPORT

Report of the Standing Committee on Finance, Economic Opportunities and Tourism (the Committee) on the recommendations for the appointment of candidates to the Western Cape Gambling and Racing Board, dated 23 August 2019, as follows:

1. Four vacancies occurred on the Western Cape Gambling and Racing Board (the Board) due to the upcoming expiry of board memberships at the end of March 2019. Three of the Board members' terms were extended to March 2020; however, one of these Board members, Ms Julinda Gantana, was appointed as Acting Head of the Provincial Treasury and could no longer serve on the Board, and thus resigned as a Board member.
2. The Provincial Treasury advertised the vacant Board member positions in the *Provincial Gazette*, *Vukani*, the *Mail & Guardian*, *Die Burger* and *Weekend Argus* on 26, 27 and 28 July 2018, and on the Provincial Government Jobs Portal.
3. The Committee was requested, by a letter of referral sent on 30 July 2019 to the Office of the Speaker at the Western Cape Provincial Parliament, to recommend candidates to fill the four vacancies. The matter was referred to the Committee in the ATC of 2 August 2019.
4. Section 3(1) of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996, as amended) stipulates: "The Board shall consist of seven members, appointed on a part-time basis, by the Executive Council in accordance with the prescribed procedure, which shall provide for public participation in the nomination of candidates for appointment; provided that the standing committee of the Provincial Legislature responsible for this Act shall evaluate all candidates as to their suitability for appointment."
5. On 6 August 2019, the Provincial Treasury briefed the Committee on the process leading to the shortlisting of candidates. The Committee was provided with a list of 13 candidates to evaluate. The Committee then resolved to evaluate the candidates through an interview process.

6. One candidate, Ms June Williams, declined the interview as she had already accepted a position on the independent audit committee in the Western Cape Gambling and Racing Board.
7. The Committee, having interviewed the 12 candidates, reached consensus and recommended the following candidates in alphabetical order:

### KOMITEEVERSLAG

Verslag van die Staande Komitee oor Finansies, Ekonomiese Geleentede en Toerisme (die Komitee) oor die aanbevelings vir die aanstelling van kandidate vir die Wes-Kaapse Raad op Dobbelary en Wedrenne, gedateer 23 Augustus 2019, soos volg:

1. Vier vakatures het in die Wes-Kaapse Raad op Dobbelary en Wedrenne (die Raad) ontstaan as gevolg van die verstryking van raadslidmaatskap aan die einde van Maart 2019. Die termyn van drie raadslede is tot Maart 2020 verleng; een raadslid, me Julinda Gantana, is as waarnemende hoof van die Provinsiale Tesourie aangestel en kon dus nie langer in die Raad dien nie en sy het gevolglik as raadslid bedank.
2. Die Provinsiale Tesourie het die vakante raadslidposisies op 26, 27 en 28 Julie 2018 in die *Provinsiale Koerant*, *Vukani*, die *Mail & Guardian*, *Die Burger* en *Weekend Argus*, asook op die provinsiale regering se werkgeleentheidsportaal geadverteer.
3. Die Komitee is versoek, in 'n verwysingsbrief wat op 30 Julie 2019 aan die Kantoor van die Speaker van die Wes-Kaapse Provinsiale Parlement gestuur is, om kandidate aan te beveel om die vier vakatures te vul. Die aangeleentheid is in die ATK van 2 Augustus 2019 na die Komitee verwys.
4. Artikel 3(1) van die Wes-Kaapse Wet op Dobbelary en Wedrenne, 1996 (Wet 4 van 1996, soos gewysig) bepaal: "Die Raad bestaan uit sewe lede wat op 'n deelydse grondslag deur die Uitvoerende Raad aangestel word in ooreenstemming met die voorgeskrewe prosedure, wat voorsiening maak vir openbare deelname aan die benoeming van kandidate vir aanstelling; met dien verstande dat die staande komitee van die Provinsiale Wetgewer wat vir hierdie Wet verantwoordelik is, al die kandidate se geskiktheid vir aanstelling in die Raad moet evalueer."
5. Op 6 Augustus 2019 het die Provinsiale Tesourie die Komitee ingelig oor die proses wat daartoe lei om die kortlys van kandidate op te stel. 'n Lys van 13 kandidate vir beoordeling

is aan die Komitee voorgelê. Die Komitee het daarna besluit om die kandidate deur middel van 'n onderhoudproses te beoordeel.

6. Een kandidaat, me June Williams, het die onderhoud van die hand gewys omdat sy reeds 'n posisie in 'n onafhanklike ouditkomitee van die Wes-Kaapse Raad op Dobbelary en Wedrenne aanvaar het.
