2. Report of Public Protector:

In a report by the Public Protector, dated 11 June 2018, and titled *Report on investigation into allegations of breach of the provisions of the Executive Ethics Code by the Premier of the Western Cape Provincial Government, Honourable Helen Zille*, the Public Protector directed that the following remedial action be taken:

The Speaker of the Western Cape Provincial Legislature (Speaker) must, within 30 working days from the date of the report, table it before the Western Cape Provincial Legislature for it to take appropriate action to hold the Premier accountable as contemplated in sections 114(2), 133(2) & 3(a) and 136(1) & 2(b) of the Constitution.

The last date for tabling of the Public Protector's report, based on the period of 30 working days referred to in that report, is 23 July 2018.

On Wednesday 4 July 2018 the Speaker and the Western Cape Provincial Parliament were served with court papers wherein the Premier seeks to interdict the Speaker and the Western Cape Provincial Parliament from implementing the remedial action in the Public Protector's report. The Premier's application for an interdict will be heard in the Gauteng Provincial Division of the High Court on 17 July 2018. The Western Cape Provincial Parliament will not oppose the application.

Unless the Speaker is served with a court order directing otherwise, the Speaker will table the Public Protector's report on 23 July 2018.
