- (3) whether she has initiated any formal inquiry or investigation to determine whether the Education Department's accounting officer committed financial misconduct in the light of the R3,8 billion shortfall, as required by Section 81(1)(a) of the PFMA; if not, why not; if so, what are the relevant details?
