Ms R Windvogel: The growing tide of violent crime in the Western Cape: its roots in social ills, the failure of the responses of the provincial government and the devastating impact that it has on communities, health facilities and social development programmes.

NOTICES OF MOTION (*11 September 2025*)

1. Mr M K Sayed: That the House welcomes the firm commitment made by the Minister of International Relations and Cooperation, Ronald Lamola, to continue fighting Israel's ongoing genocidal actions against the Palestinian people at the International Court of Justice; further notes that South Africa, having endured the brutalities of apartheid, carries both a moral and historical duty to stand with oppressed peoples across the world; welcomes Minister Lamola's strong and principled stance on the global stage, which reinforces our country's leadership in the fight for human rights, justice and the rule of international law; acknowledges that this unwavering position reflects the enduring values of the liberation movement and the spirit of solidarity that defined South Africa's own struggle; calls on all sectors of South African society, including this provincial government,

to support the national government's efforts at the World Court and to intensify solidarity with the people of Palestine until their freedom, dignity and self-determination are achieved; further welcomes the upcoming Mass March for Palestine to be held on 27 September 2025, from Muir Street to Parliament in Cape Town, organised by a broad coalition of political and civil society organisations; and urges residents of the Western Cape to attend this historic march in large numbers.

2. Mr M K Sayed: That the House notes with concern the ongoing plight of the residents of the Freedom Park Informal Settlement in Greyton, under the Theewaterskloof Municipality, who are facing threats of eviction and the continued denial of basic services, such as water and sanitation, which are fundamental human rights; further notes that many of the residents of Freedom Park are vulnerable, including elderly people with disabilities and chronic illnesses, who are being forced to live without dignified access to sanitation, and who face intimidation from municipal officials rather than support; notes that the land currently occupied by Freedom Park residents, erf 595, belongs to the Theewaterskloof Municipality and had previously been identified and approved for the relocation of Madiba Park residents, but that the DA-led coalition in the Theewaterskloof Municipality has refused to implement the decision since it took over, leaving residents in a state of insecurity and hardship; acknowledges that a delegation of the ANC visited the community of Freedom Park yesterday to engage with residents and reaffirm their commitment to upholding their rights and dignity; resolves to condemn any unlawful evictions; and calls on the Theewaterskloof Municipality to provide basic services, such as water and sanitation, immediately to Freedom Park residents and to ensure that the Council's previous decision on the relocation of informal settlement residents be implemented in a fair, transparent and just manner.
3. Mr M B Nqgentsu: That the House notes with grave concern the ongoing crisis of violent crime in the Western Cape, which continues to claim innocent lives, destabilise communities and erode the sense of safety and security that all residents are entitled to; further notes that the Western Cape remains one of the most affected provinces in the country, with gang violence, drug-related crime and violent shootings having reached alarming levels; welcomes the recent political engagement between ANC structures in Cape Town and the Acting Minister of Police, Professor Firoz Cachalia, where the urgent matter of violent crime in the province was discussed; recognises that this dialogue marks a crucial step towards building collaborative and people-centred solutions, ensuring that the perspectives of communities, ANC structures and the caucus are part of the national discourse on policing and safety; and acknowledges the ANC caucus in the Western Cape provincial legislature for its proactive contribution in these discussions, bringing forward the lived experiences of communities and championing the urgent need for decisive intervention.
4. Mr M B Nqgentsu: That the House expresses outrage at the gang-related shooting outside the Athlone Magistrate's Court where a man was brutally gunned down, reigniting fears of revenge attacks and escalating violence in our communities; notes that this tragic incident is yet another stark reminder of the DA-led provincial government's failure to protect citizens, to maintain law and order and to provide even the most basic security in high-risk areas; further notes with deep concern that, while residents live in constant fear of gang retaliation, our courts – supposed to be bastions of justice – have themselves become dangerous zones under DA mismanagement; welcomes the swift arrest of a suspect in relation to this killing; commends the South African Police Service for their diligent work

in swiftly apprehending the alleged perpetrator; and calls on the Minister of Police to deploy urgently enhanced, intelligence-led operations targeting gang networks in the Western Cape, to strengthen security at all judicial facilities and to work with national authorities to dismantle these entrenched criminal structures.

5. Ms N D Nkondlo: That the House notes with grave concern the shocking revelations that police and military-grade weapons are being smuggled from Namibia into the Western Cape where they are arming gangs and fuelling the bloodshed that continues to devastate our communities; further notes that it has been confirmed that these firearms, including pistols and even AK-47s, are entering Cape Town concealed in trucks transporting fresh produce and flowers, while the DA-led provincial government sits idly by, failing to act decisively against this scourge; further notes that this failure has enabled international smuggling syndicates to thrive, placing weapons of war in the hands of criminals who destabilise our society; further notes with alarm that this is not the first time police firearms have found their way into the hands of gangs, and recalls the 31 missing firearms from City of Cape Town's law enforcement officers that remain unaccounted for to this day; acknowledges that this crisis is not merely the result of porous borders, but also of weak governance and a total lack of coordination between law enforcement and intelligence structures in the Western Cape; therefore, calls on the Minister of Police and all relevant national authorities to intensify cross-border cooperation with Namibia and other SADC countries to close the loopholes in trade routes exploited by syndicates urgently and to strengthen intelligence-driven policing in the province; and also calls for an immediate audit of provincial law enforcement structures to establish why, under DA governance, the Western Cape has become a haven for gangsters and smugglers, while ordinary citizens continue to pay the price with their lives.

Me R Windvogel: Die toenemende vlaag van geweldsmisdaad in die Wes-Kaap: die wortels daarvan in maatskaplike euwels, die reaksies van die provinsiale regering wat nie slaag nie, en die verwoestende impak wat dit op gemeenskappe, gesondheidsfasiliteite en programme vir maatskaplike ontwikkeling het.

DAGORDER

Oorweging en finalisering van die Wysigingswetsontwerp op Monitering en Ondersteuning van Munisipaliteite [W 8B–2023] (Minister van Plaaslike Regering, Omgewingsake en Ontwikkelingsbeplanning).

VERDERE WERKSAAMHEDE

VOORSTELLE MET KENNISGEWING (11 September 2025)

1. Mnr M K Sayed: Die dat Huis die sterk verbintenis verwelkom wat deur die Minister van Internasionale Betrekkinge en Samewerking, Ronald Lamola, gemaak is om voort te gaan om Israel se voortgesette volksmoordoptrede teen die Palestyne in die Internasionale Geregshof te beveg; verder kennis neem dat Suid-Afrika, wat die onmenslikheid van apartheid moes verduur, 'n morele sowel as geskiedkundige plig het om saam te staan met mense in die wêreld wat onderdruk word; Minister Lamola se sterk en beginselvaste stand op 'n internasionaal platform verwelkom, wat ons land se leierskap in die stryd vir menseregte, geregtigheid en die oppergesag van die internasionale reg herbevestig; erkenning gee dat hierdie onwrikbare stand die blywende waardes van die bevrydingstryd

en die gees van samehorigheid weerspieël wat Suid-Afrika se eie stryd omskryf; 'n beroep doen op alle sektore van die Suid-Afrikaanse samelewing, insluitende hierdie provinsiale regering, om die nasionale regering se pogings by die Wêreldhof te steun en om solidariteit met die Palestyne te versterk totdat hul vryheid, waardigheid en vrye wil bereik word; verder die komende Massa-optog vir Palestina verwelkom wat op 27 September 2025 vanaf Muirstraat na die Parlement in Kaapstad gehou sal word, en deur 'n groot koalisie van politieke en burgerlikesamelewingsorganisasies gereël is; en inwoners van die Wes-Kaap aanspoor om hierdie geskiedkundige optog in groot getalle by te woon.

2. Mnr M K Sayed: Dat die Huis met kommer kennis neem van die voortgesette benarde posisie van die inwoners van die Freedom Park- informele nedersetting in Greyton, in die Theewaterskloof-munisipaliteit, wat dreigemente van uitsetting en die voortgesette weerhouding van basiese dienste, soos water en sanitasie, wat fundamentele menseregte is, die hoof moet bied; verder kennis neem dat talle van die Freedom Park-inwoners weerloos is, insluitende bejaardes met gestremdhede en chroniese siektes, wat gedwonge sonder waardige toegang tot sanitasie moet leef, en wat intimidasie deur munisipale amptenare eerder as ondersteuning die hoof moet bied; kennis neem dat die grond wat deur Freedom Park-inwoners beset word, erf 595, aan die Theewaterskloof-munisipaliteit behoort en voorheen geïdentifiseer en goedgekeur is vir die hervestiging van Madiba Park-inwoners, maar dat die DA-beheerde koalisie by die Theewaterskloof-munisipaliteit geweier het om die besluit te implementeer sedert hy aan bewind gekom het, wat inwoners in 'n toestand van onsekerheid en swaarkry laat; erkenning gee dat 'n afvaardiging van die ANC die Freedom Park-gemeenskap gister besoek het om met inwoners te skakel en hul verbintenis tot die handhawing van hul regte en waardigheid te herbevestig; besluit om enige onwettige uitsettings te veroordeel; en 'n beroep doen op die Theewaterskloof-munisipaliteit om dadelik basiese dienste, soos water en sanitasie, aan Freedom Park-inwoners te verskaf en om toe te sien dat die Raad se vorige besluit oor die hervestiging van inwoners van informele nedersettings op 'n regverdige, deursigtige en regmatige manier geïmplementeer word.
3. Mnr M B Nqgentsu: Dat die Huis met diepe kommer kennis neem van die voortslepende krisis met geweldsmisdaad in die Wes-Kaap wat steeds onskuldige lewens eis, gemeenskappe destabiliseer en die veiligheid en sekuriteit vernietig waarop alle inwoners geregtig is; verder kennis neem dat die Wes-Kaap steeds een van die provinsies in die land is wat die meeste geraak word, en dat bendegegeweld, dwelmverwante misdaad en gewelddadige skietvoorvalle kommerwekkende vlakke bereik het; die onlangse politieke skakeling tussen ANC-strukture in Kaapstad en die Waarnemende Minister van Polisie, professor Firoz Cachalia, verwelkom waar die dringende kwessie van geweldsmisdaad in die provinsie bespreek is; erkenning gee dat hierdie gesprek 'n kritieke stap is om samewerkende en mensgesentreerde oplossings te skep, en te verseker dat die perspektiewe van gemeenskappe, ANC-strukture en die kookus deel van die nasionale gesprek oor polisiëring en veiligheid is; en erkenning gee aan die ANC-kookus in die Wes-Kaapse provinsiale wetgewer vir sy proaktiewe bydrae tot hierdie gesprekke, wat die lewenservarings van gemeenskappe beklemtoon en die dringende behoefte aan beslissende ingryping voorstaan.
4. Mnr M B Nqgentsu: Dat Die Huis woede uitspreek oor die bende-erwante skietvoorval buite die Athlone-landdroshof waar 'n man wreed doodgeskiet is, wat vrese vir wraak-aanvalle en toenemende geweld in ons gemeenskappe aanwakker; kennis neem dat hierdie tragiese voorval nog 'n rou herinnering is aan die DA-beheerde provinsiale regering se

versuim om inwoners te beskerm, om wet en order te handhaaf en om selfs die mees basiese sekuriteit in hoërisikogebiede te verskaf; met diepe kommer kennis neem dat, terwyl inwoners voortdurende in vrees vir bendeweerwraak leef, ons howe – wat veronderstel is om die bastions van geregtigheid te wees – self gevaarsones onder DA-wanbestuur geword het; die vinnige inhegtenisneming van 'n verdagte in verband met hierdie moord verwelkom; die Suid-Afrikaanse Polisiediens aanprys vir hul ywerige werk om die vermeende skuldige vas te trek; en 'n beroep doen op die Minister van Polisie om dringende verbeterde operasies te ontplooi wat deur intelligensie gelei word en bendenetwerke in die Wes-Kaap teiken, om sekuriteit by alle regspraakfasiliteite te versterk en om saam met nasionale owerhede te werk om hierdie diep ingewortelde misdaadstrukture te ontbloot.

5. Me N D Nkondlo: Dat die Huis met diepe kommer kennis neem van die skokonthullings dat polisie- en militêregehaltewapens uit Namibië na die Wes-Kaap gesmokkel word waar hulle bendes bewapen en die bloedvergieting aanvuur wat ons gemeenskappe steeds verwoes; verder kennis neem dat daar bevestig is dat hierdie vuurwapens, insluitende pistole en selfs AK-47's, Kaapstad binnekom deur versteek te word in vragmotors wat vars produkte en blomme vervoer, terwyl die DA-beheerde provinsiale regering arms gevou sit, en nie beslissend optree teen die euwel nie; verder kennis neem dat hierdie versuim internasionale smokkelsindikate in staat gestel het om te floreer, en oorlogswapens in die hande van misdadigers geplaas het wat ons samelewing destabiliseer; verder met kommer kennis neem dat dit nie die eerste keer is dat polisievuurwapens in bendes se hande beland nie, en onthou van die 31 vermiste vuurwapens van die Stad Kaapstad se wetstoepassingsbeamptes wat tot op vandag steeds onverklaard is; erkenning gee dat hierdie krisis nie net 'n gevolg is van poreuse grense nie, maar ook van swak bestuurtoesig en 'n algehele gebrek aan koördinering tussen wetstoepassing en intelligensiestrukture in die Wes-Kaap; dus 'n beroep doen op die Minister van Polisie en alle toepaslike nasionale owerhede om oorgrenssamewerking met Namibië en ander SAOG-lande te versterk om die skuiwergate in handelsroetes dringend toe te stop wat deur sindikate uitgebuit word, en om polisiëring wat intelligensiegedrewe is, in die provinsie te versterk; en ook 'n beroep doen vir die onmiddellike oudit van provinsiale wetstoepassingstrukture om te bepaal hoekom, onder DA-bestuurtoesig, die Wes-Kaap 'n veilige hawe vir benedeledede en smokkelaars geword het, terwyl gewone inwoners steeds met hul lewens boet.
