1. Mr T A Simmers to ask Mr A W Bredell, Minister of Local Government, Environmental Affairs and Development Planning:

With reference to the 27 new projects signed off for renewable energy producers by Minister Radebe:

Whether any of the new wind, solar, photovoltaic and concentrated solar-power projects will be rolled out in the Western Cape; if not, why not; if so, (a) what areas have been identified for these new projects and (b) how many job opportunities will be created?

2. Mr T A Simmers to ask Mr A W Bredell, Minister of Local Government, Environmental Affairs and Development Planning:

Over the last 15 years, R1,8 billion has been raised by the plastic-bag levy:

- (1) Whether funds raised through the plastic-bag levy are ring-fenced; if not, why not; if so, what are the relevant details;
- (2) (a) what amount of the plastic-bag levy has been allocated to recycling projects nationally, (b) what amount of the levy has been spent on recycling projects within the province and (c) what are the relevant details of the recycling projects in the province?

3. Ms M M Wenger to ask Mr D Plato, Minister of Community Safety:

- (1) What were the policing needs and priorities (PNPs) submitted to the national police service for the (a) first, (b) second and (c) third quarter of 2017/18;
- (2) whether the national policing policy has taken these PNPs into account; if not, why not; if so, what are the relevant details?

4. Ms P Z Lekker to ask Mr D Plato, Minister of Community Safety:

- (1) (a) How many CCTV cameras are in the (i) Khayelithsa and (ii) Nyanga police precinct, (b) how many of these are in working order, (c) how many are out of order, (d) why are the cameras out of order and (e) what is his Department doing to address this problem;
- (2) whether he can give an account of incidents where evidence was obtained through the use of CCTV cameras in Khayelitsha; if not, why not; if so, what are the relevant details?

5. Ms P Z Lekker to ask Mr D Plato, Minister of Community Safety:

(a) How many cameras are installed in crime hotspots in Site C, (b) how many are (i) working and (ii) out of order, (b) why are they out of order, (c) how long has the CCTV camera in Site C near the Caltex garage, where a police officer was killed last week, not been working and (d) why has it not been working?

With reference to the Youth and Religion Project:

(a) How much has his Department spent since its inception date and (b) on which churches and/or ministries?

7. Ms S Davids to ask Mr B S Madikizela, Minister of Human Settlements:

(a) What is the total number of backyard dwellers that has been registered with his Department since 2009 until the latest date for which information is available and (b) what has been the progress with backyarder programmes in the province?

8. Mr P Makeleni to ask Mr A T Fritz, Minister of Social Development:

(a) What is the total number of drug-related cases that his Department has responded to since 2014 and (b) what is the breakdown per (i) age, (ii) race, (iii) gender and (iv) area of residence?

9. Ms N D Nkondlo to ask Mr D A C Grant, Minister of Transport and Public Works:

(1) (a) Why has the Kwa-Faku School not been demolished while the commitment was given to the school last year in November after the school closed, (b) what has he and his Department done to address this, (c) how will this further delay the building of

- the new school, seen against the commitment that was made of a new school being built by January 2019;
- (2) whether the school and the relevant stakeholders have been informed of this delay and of subsequent plans to start the demolition and construction process with new deadlines; if not, why not; if so, what are the relevant details?

10. Ms N D Nkondlo to ask Mr A R Winde, Minister of Economic Opportunities:

(a) Whether he can provide a list of new and small businesses that have been established in the agro-processing and tourism sector as part of Project Khulisa, (b) out of these, (i) how many are 51%-and-above black-owned enterprises, as defined in the BBBEE Amended Codes, (ii) how many are based in the Western Cape by shareholder ownership and primary operations (domicilium) and (iii) how much of the shareholding is owned by women, the youth and/or people with disabilities, (c) how has the Department enabled these companies to participate in the economy, (d) has he and the Department ever held engagements with the agri-workers where there are high risks of job losses due to the drought; if so, what kind of engagements were held, what were the outcomes thereof and what evidence therefore can be submitted; if not, why not?

11. Mr Q R Dyantyi to ask Mr D A C Grant, Minister of Transport and Public Works:

- (1) (a) Why does Go George and Fleet Management (GIPTN) fall under Community Safety and not Finance, (b) what agreements and arrangements were made between the Executive Mayor and the Municipal Manager with the previous Director of Human Settlements who is now the Director of Community Safety and (c) why was an instruction issued to transfer a substantial amount of funds (from national grant funding) from the GIPTN budget to the Province;
- (2) whether the transfer of these funds is proper procedure; if not, why not; if so; what are the relevant details;
- (3) whether he will institute a forensic audit; if not, why not; if so, what are the timelines?
