#### 1. Prof N Mbombo to ask Mr I M Sileku, Minister of Mobility:

Given anecdotal reports that Government Garage-branded (GG-branded) vehicles have increasingly been targeted in robberies, placing public servants and their families in danger, and considering that GG vehicles are managed by Government Motor Transport (GMT):

(a) What is the total cost to each department for the management and operation of GG vehicles, (b) how many incidents of robbery or related crimes involving GG-branded vehicles have been reported in each department over the past three years and (c) what measures has the Department put in place to (i) reduce the risk of such incidents and (ii) improve the safety of public servants who rely on GG vehicles?

## 2. Mr B N Herron to ask Mr A W Bredell, Minister of Local Government, Environmental Affairs and Development Planning:

With reference to his reply to question 16 of 26 June 2025:

- (1) What defects in the municipality's pleadings led to the litigation being unsuccessful:
- (2) whether the municipality failed to amend its pleadings within the 20-day period afforded by the court; if so, what explanation has been provided for this non-compliance;
- (3) whether the municipality's claims have prescribed; if so, (a) what is the total value of the prescribed claims and (b) who will be held accountable for the resultant financial loss to the municipality;

(4) (a) what alternative intervention measures has the provincial government implemented or considered in terms of section 139 of the Constitution in the light of the municipality's failure to prosecute the claims effectively and (b) what is the total cost incurred by the Municipality on legal proceedings to date?

- (2) (a)(i) how was the target of 115 upgrade projects identified for the MTEF and (ii) what upgrades or services will be delivered in each of these projects and (b) of the 115 projects, how many (i) are designated as in-situ upgrading projects and (ii) involve the relocation of households;
- (3) (a) how many households are projected to be relocated to temporary relocation areas (TRAs) during the MTEF period and (b) what is the (i) average and (ii) longest period of stay for households in TRAs before access to permanent housing is provided;
- (4) (a) what is the total amount budgeted for the maintenance and management of TRAs in the current MTEF and (b) how does this compare to the budget allocated to the permanent upgrading of informal settlements;
- (5) with regard to the 26 TRAs that already exist, (a) when were they established, (b) what was the cause for their establishments and (c) where are they located?

- (2) (a) which projects have been impacted by cuts to the Human Settlements Development Grant (HSDG) and Informal Settlements Upgrading Partnership Grant (ISUPG) and (b) how have the cuts from both the (i) HSDG and (ii) ISUPG impacted the baseline of the MTEF?

#### 6. Mr T C R Walters to ask Mr A R Winde, Premier:

With regard to the Energy and Water Council:

(a) How does the work of the council feed into the planning of the different departments of the Western Cape Government and (b) what insights into water and energy resilience have been revealed through the work of the council?

(a) What is the current SAPS backlog of DNA cases in the province, broken down by (i) GBV or rape, (ii) murder, (iii) property crime and (iv) missing persons, (b) what is the average turnaround time calculated from the submission of samples to the laboratory to the delivery of test results, (c)(i) how many cases are at risk of being removed from court rolls or being withdrawn because the forensic evidence has been delayed and (ii) how many cases have already been removed or withdrawn, (d)(i) what is the current staff complement at the SAPS Forensic Science Laboratory and (ii) how does this compare to the required or ideal staffing level and (e) how many SAPS forensic laboratories are in the province?

- (3) how many illegal firearms have been confiscated by SAPS in the province in (a) 2023, (b) 2024 and (c) 2025 to date?

With reference to the Back on Track Programme:

(a) What is the projected cost for the 2025/26 financial year, (b)(i) how many teachers are currently involved in implementing the programme and (ii) how are they allocated across districts, (c) how many learners are currently enrolled in the programme broken down by grade, (d)(i) which grades have been prioritised for support through the programme and (ii) what was the rationale for choosing these grades, (e)(i) how many schools per district are currently participating in the programme and (ii) what criteria were used to determine school selection, (f) what measurable outcomes have been achieved by the programme and (g) how many learners in no-fee schools compared to learners in fee-paying schools are benefitting from the programme?

(a) What is the estimated impact on the delivery of essential services in schools for the last three financial years and (b) what measures have been put in place to mitigate these effects, specifically in respect of (i) the number of educator posts required versus what the budget can accommodate, (ii) the budgeted versus the actual expenditure on learner support material (LSM), (iii) the grades and subjects most affected by LSM shortages, (iv) the budgeted versus the actual expenditure on the School Nutrition Programme, (v) the budgeted versus the actual expenditure on the School Transport Programme, (vi) the planned versus the actual expenditure on school infrastructure maintenance and upgrades and (vii) the additional funding required each year to restore services?

With reference to the issue of so-called "ghost teachers" in the education system:

- (1) (a) How many cases of ghost teachers have been identified in (i) 2022/23, (ii) 2023/24 and (iii) 2024/25 to date, broken down by education district, (b) what was the total estimated cost to the provincial fiscus of these ghost teacher salaries for the same period as in (a) above, (c) what internal control and verification systems are currently in place to (i) detect and (ii) prevent ghost teachers being paid, (d) how many investigations into cases of ghost teachers are currently ongoing and (e) what measures are being taken to ensure disciplinary action or criminal prosecution where fraud is found;
- (2) (a) what is the impact of cases of ghost teachers on the availability of funded educator posts in the province, (b) how has this affected classroom delivery, specifically with respect to learner—teacher ratios in high-pressure districts, (c) how many of the cases of ghost teacher involved collusion by school management or district officials and (d) what remedial measures have been instituted to prevent any recurrence;
- (3) whether his Department has any plans to make use of digital biometric attendance, centralised HR or payroll auditing or collaboration with the Auditor-General and the Provincial Treasury to strengthen oversight and to reduce the risk of ghost teachers remaining undetected; if so, what are the timelines for implementation?

- (1) (a)(i) What is the current status of the N2 Express Pilot Integration Project and (ii) what key milestones have been achieved to date, (b)(i) which routes or areas are currently included in the N2 Express Pilot and (ii) how were they selected and (c) what measurable outcomes or indicators are being used to assess the success of the pilot project;
- (2) whether there are plans to expand the N2 Express integration model to other corridors or regions in the province; if so, which areas are being considered;
- (3) what lessons have been learned from the pilot project that will inform future public transport integration strategies in the province and (b) what (i) budget and (ii) resources have been allocated for the continuation or expansion of the N2 Express integration initiative in the last three financial years?

(a) What is the current number of informal settlements in the province, broken down by (i) district and (ii) municipality, (b) how many informal settlements are targeted for formal upgrading over the next three financial years, (c) what budget has been allocated for the upgrading of informal settlements in the last three financial years, (d) how much has been allocated to the Province by the National Treasury from the Informal Settlements Upgrading Partnership Grant (ISUPG) for (i) 2023/24, (ii) 2024/25 and (iii) 2025/26, (e) how much is needed to build housing units and upgrade service infrastructure, (f) how many housing units are expected to be delivered through these upgrading projects, (g)(i) how many residents have been relocated from informal settlements over the past three years and (ii) what were the primary reasons for their relocation and (h) what mechanisms exist for residents to raise concerns or provide input on informal settlement upgrading projects?

With regard to the Social Housing Regulatory Authority:

- (1) Whether the Social Housing Regulatory Authority (SHRA) has received, considered or approved any applications from Communicare NPC (or its subsidiary Goodfind Properties (Pty) Ltd) relating to the transfer, disposal or vesting of housing stock in Ruyterwacht (formerly Eppingtuin), Goodwood; if so, what was the outcome of such applications;
- (2) whether copies can be made available of any vesting certificates, *Government Gazette* notices or other official authorisations evidencing the lawful transfer of the Ruyterwacht properties from the State or the Goodwood Municipality to Communicare NPC;
- (3) whether SHRA granted approval in terms of sections 11 and 12 of the Social Housing Act, 2008 (Act 16 of 2008), for the disposal of any Ruyterwacht housing stock by Communicare NPC or Goodfind Properties (Pty) Ltd; if not, what enforcement action has SHRA taken to ensure compliance; if so, (a) what conditions were imposed and (b) were the conditions complied with?

#### 17. Ms N D Nkondlo to ask Ms D M Baartman, Minister of Finance:

With regard to the Competition Commission's Cost of Living Report (August 2025):

- (1) Whether her Department has engaged with the findings of the Competition Commission's Cost of Living Report (August 2025) regarding the disproportionate impact of rising food, transport, housing and utility costs on low-income households in Cape Town; if so, what measures are being implemented to provide relief to vulnerable residents in the province;
- (2) in the 1ght of evidence of "price stickiness" in staple foods (such as bread, maize meal, chicken, eggs and sunflower oil) where producer cost reductions are not passed on to consumers, what steps is her Department taking to address anti-competitive behaviour in food retail markets, particularly in urban centres such as Cape Town;
- (3) given that electricity tariffs have increased by 68% and water by 50% over the past five years, with Cape Town residents facing compounded municipal tariff hikes, what interventions are being considered by her Department to curb the burden of administered prices on households, especially in informal settlements and low-income communities?

- (3) whether her Department has a dedicated strategy to disrupt the flow of automatic rifles, such as AK-47s, smuggled along Namibian routes; if so, what are the relevant details;
- (4) what is the impact of these firearms on gang violence in communities such as Nyanga, Khayelitsha, Mitchells Plain and the broader Cape Flats?

- (2) whether any other municipalities in the province are currently under consideration for intervention by his Department; if so, which municipalities are being assessed;
- (3) whether any of the municipalities in (2) above are being considered for potential dissolution in terms of section 139(1)(c) of the Constitution; if so, what are the relevant details;
- (4) why were those support efforts provided to the municipality insufficient to restore functionality;
- (5) whether any weaknesses were identified in the provincial support model; if so, what are the relevant details:
- (6) (a) how will the appointment of an Administrator address the systemic governance failures in the municipality and (b) what measures are in place to ensure that the Administrator acts impartially;
- (7) (a) what lessons has his Department drawn from the Knysna intervention and (b) how will these be applied to improve support for other struggling municipalities across the province?
