(a) What is the budget allocated to educate a child in the province, (b) what are the details and the budget of the Transform to Perform Programme, which shows tangible evidence of schools that have been turned around, in (i) 2014, (ii) 2015, (iii) 2016, (iv) 2017, (v) 2018, (vi) 2019, (vii) 2020 and (viii) 2021 to date?

With regard to the over 20 000 learners accepted at more than one school by 24 June 2021:

(1) How many parents have accepted the school of choice for their children for placement by 25 June;

(2) whether these are the only new applications received; if so, (a) what is the number of learners per grade and (b) how many were placed automatically due to non-compliance by the confirmation date?

(a) What competitions (such as the "Story Star" competition) has her Department offered at schools in (i) 2017, (ii) 2018, (iii) 2019, (iv) 2020 and (v) 2021 to date, (b) what is planned for the 2022 academic year and (c) what are the aims of each of the projects?

(a) What were the outcomes of the last TB council meeting held on 24 June 2021, (b) what benefits does the TB dashboard offer for the residents of the province and (c) what has the (i) TB infection rate, (ii) TB-related death rate and (iii) TB recovery rate been in (aa) 2016, (bb) 2017, (cc) 2018, (dd) 2019, (ee) 2020 and (ff) 2021 to date?

(a) What does the SAPS define as a "known" drug house, (b) how many known drug houses are there in the province, (c) when was this data last recorded, (d) what is the process behind their prospective closure in terms of the mandate of the police service, (e) what percentage and how many of these drug houses are in (i) the metropolitan area and (ii) rural areas and (f) how many drug houses have been shut down in the (i) 2017/18, (ii) 2018/19, (iii) 2019/20 and (iv) 2020/21 financial years?

With reference to section 252A of the Criminal Procedure Act, 1977 (Act 51 of 1997):

- (a) What is defined as a "trap" for informants to uncover and investigate operations in terms of section 252A of the Criminal Procedure Act, 1977, in relation to illegal drug trading, (b) what amount has been spent on this in the (i) 2017/18, (ii) 2018/19 and (iii) 2019/20 financial years and (c) what are the rewards offered to informants;
- (2) whether traps refer to informants as individuals; if so, how many of the traps have contributed to (a) arrests, (b) convictions and (c) the closure of drug houses?

#### 10. Mr R I Allen to ask Mr T A Fritz, Minister of Community Safety:

With reference to the announcement of the allocation of 50 additional vehicles to the province during the second quarter of 2021:

- (1) (a) What is the required current establishment of SAPS vehicles in the province and (b) what is the actual number of vehicles in (i) 2020 and (ii) 2021;
- (2) whether these vehicles will be used for visible policing; if not, which division or divisions or station or stations will be the beneficiaries thereof; if so, what are the relevant details?

Whether the Province has established any alternative initiatives in the absence of the national Blue Dot and Green Dot water programmes; if not, why not; if so, (a) what are the relevant details, (b) what are the trends indicated from reports emanating from the aforementioned alternatives and (c) what impact has the inactivity of the programmes had on the quality of water in the province?

#### 15. Mr B N Herron to ask Mr T A Simmers, Minister of Human Settlements:

With regard to residents of KTC and Nyanga claiming that 100 families in KTC were to be included in the Forest Village Housing Project in Eerste River and that this has not happened:

(a) What are the details of the housing allocations in the Forest Village Housing Project, (b) why were housing opportunities in the project not allocated to KTC residents, (c) whether there are any plans to include 100 beneficiaries from KTC in this project; if so, (i) when and (ii) how will the beneficiaries be identified; if not, (iii) why not and (iv) what are the relevant details?
