With reference to his reply to interpellation 1 of 2 September 2021

- (1) (a) What are the details of the course of action taken after the report was made public,(b) what are the full list of questions that were asked to the City of Cape Town and(c) what are the detailed list of replies provided by the municipality during the pre-investigation assessment that he referred to;
- (2) (a) what are the timeframes of the process between the start of the pre-investigation assessment and the initiation of the section 106 investigation, including (b) what are the detailed timelines of (i) when the questions were sent to the City of Cape Town, (ii) when his Department is expecting replies and (iii) when the pre-investigation will be concluded;
- (3) what are the grounds that would allow him to not initiate a section 106 investigation into corruption allegations in the City of Cape Town?

- (2) with regard to allegations he received as per his reply; (a) what is the (i) number and (ii) details of (aa) City Contractors and (bb) City officials that are implicated in the allegations, (b) what is the (i) number and (ii) details City Contractors who allegedly inflated invoices and (c) how much was lost due to this alleged fraud, (d) what is the (i) number and (ii) details of City officials implicated in the Tender manipulation

allegations and (e) what are the details of Ward councillors accused of money laundering?

- (1) Whether her Department had continued with the payment of Covid-19 relief fund for artists and athletes during the current financial year, if not, why not, if so, (a) what are the relevant details, (b) what is the total amount that has been spent on this fund and (c) what is the detailed breakdown of the spending in (i) 2020 and (ii) 2021, (d) (i) what are the details of any service providers that were involved in the process and (ii) costs associated with them, (e) what are the details of artists and athletes that were paid between in (i) 2020 and (ii) 2021, (f) how much each received and (g) what is the breakdown of beneficiaries per municipality;
- (2) (a) how many applications for the Covid-19 relief fund for artists and athletes that were received in (i) 2020 and (ii) 2021 and (b) (i) how many were rejected and (ii) the reasons for it?

- (1) whether a certain company, whose name has been furnished to his Department for the purpose of his reply, oversee the entire provincial health infrastructure programme; if so, (a) when were they appointed, (b) for which duration (c) what is the total amount paid to this company for this service and (d) and how does this impact on small contractors;
- (2) whether this is the most cost effective method of infrastructure provision; if so, what are the relevant details;
- (3) with regard to the appointment of a certain company whose name has been furnished to his Department for the purpose of his reply, to provide education infrastructure, (a) what was the total spend on consultants and (b) what was the amount spent on (i) white consultants and (ii) black consultants;
- (4) with regard to a certain company whose name has been furnished to his Department for the purpose of his reply, (a) how many times has the cost of the original contract value been exceeded by 20% and (b) what are the full details regarding the 4 Dorp street project;
- (5) (a) what was the original budget for the upgrading of the Premiers residence which commenced in 2020 and (b) what is the total spent to date?

- (1) (a) What is the number of vaccine sites that are (i) planned and (ii) active for each sub district in the province, (b) what is the detailed list of all vaccine sites that are active in the province per suburb and (c) what is the number of vaccine administrators that have (i) applied, (ii) been trained and (iii) been deployed to sites as at the latest date for which information is available;
- (2) (a) what is the total breakdown of people that have been vaccinated in the province as at the latest date for which information is available and (b) what is the breakdown according to (i) age, (ii) race, (iii) gender and (iv) sub district?

- (2) whether she can provide a detailed breakdown of applications that have been (a) accepted, (b) rejected and on (c) waiting list according to (i) age, (ii) gender, (iii) race, (iv) grade, (v) education district and (vi) suburbs?

With reference to his reply to question 3 of 30 July 2021:

(a) What is the total number of backlogged cases as a result of delayed DNA processing at SAPS Forensic Science Laboratory in the Western Cape, (b) how many of these cases are related to sexual offences, (c) what measures, if any, has the national Minister of Police employed to address this issue, (d) what are the dates of when he took any such actions, (e) what is the expected timeline for the machines to become operational, (f) which methods, if any, of DNA processing has SAPS FSL utilised in the absence of the unused DNA processing machines, (g) what progress has the SAPS made with regards to re-initiating the bidding process for the servicing of the DNA processing equipment?

(a) How does SAPS define 'mob justice', (b) how many instances of mob justice have been reported in the province over the last three financial years and (c) how many individuals were (i) charged and (ii) prosecuted for crimes related to mob justice over the last three financial years?

(a) How many pregnancies at schools have been registered amongst children in Western Cape schools of the age group (i) between 10 and 14 and (ii) 15 and 18, (b) how many pregnancies have been terminated, (c) how many of these pregnancies is because of sexual abuse and (d) how many of these pregnancies involved, (i) teachers, (ii) managers, (iii) Senior Management and (iv) other learners?
