With regard to the emission of greenhouse gases in the Western Cape:

- (1) (a) How many parts per million of greenhouse gases have been emitted in (i) 2012, (ii) 2013, (iii) 2014 and (iv) 2015 and (b) what are the relevant details in this regard;
- (2) (a)(i) what are the 10 sectors that contribute the most to the emission of greenhouse gases in the province and (ii) what are the relevant details of each, (b) how many parts per million of greenhouse gases have been emitted by each of these sectors for the same period as in (1)(a), (c)(i) which sectors, if any, have demonstrated a sustained increase in greenhouse emissions and (ii) what are the relevant details and (d)(i) which sectors, if any, have demonstrated a sustained decrease in greenhouse emissions and (ii) what are the relevant details?

- (2) (a)(i) what are the 10 sectors that contribute the most to the emission of greenhouse gases in the province and (ii) what are the relevant details of each, (b) how many parts per million of greenhouse gases have been emitted by each of these sectors for the same period as in (1)(a), (c)(i) which sectors, if any, have demonstrated a sustained increase in greenhouse emissions and (ii) what are the relevant details and (d)(i) which sectors, if any, have demonstrated a sustained decrease in greenhouse emissions and (ii) what are the relevant details?

- (1) Whether his Department currently has initiatives in place to assist with the reduction of greenhouse gas emissions in the public and private sectors; if so, what are the relevant details;
- (2) what were the (a) budget breakdown and (b) details of these initiatives in (i) 2000, (ii) 2001, (iii) 2002, (iv) 2003, (v) 2004, (vi) 2005, (vii) 2006, (viii) 2007, (ix) 2008 and (x) 2009;
- (3) whether these initiatives are still in place; if not, why not; if so, what are the relevant details;
- (4) whether his Department is currently in the process of developing other initiatives or policies that aim to reduce greenhouse gas emissions in the province; if not, why not; if so, what are the relevant details?

With respect to Metrorail's decision to cancel its train service on the Northern Line between Wellington and Kraaifontein, as well as between Kraaifontein and Cape Town:

- (1) How many passengers are expected to be affected on average per weekday because of the cancellation of the (a) T3501, (b) T3502, (c) T3504, (d) T3505 and (e) T3507, train operations;
- (2) whether Metrorail has made alternative transport arrangements for the affected passengers; if so, what are the relevant details;
- (3) (a) what essential safety equipment was stripped from the area that resulted in the cancellation of the train services, (b) how much would it cost to refurbish the area so that it would be safe for the train services to resume, (c) what is the timeline for the repairs and (d) how much revenue is Metrorail expected to lose per day for the cancelled train services as stipulated in (1)?

(1) Whether his Department has an internal procurement function; if so, (a) how many employees are permanently employed by his Department for this function;

- (2) whether a certain company, whose name has been furnished to his Department for the purpose of his reply, is affiliated to his Department; if so, (a) what are the relevant details, (b) who are the directors or owners of this company and (c) what is the scope of its work;
- (3) whether his Department has outsourced its procurement function between 2020 and 2021; if not, why not; if so, (a) what was the purpose for outsourcing the procurement function, (b) what processes did his Department go through in order to award this contract, (c) what counsel did his Department receive (i) internally from the Western Cape Government and (ii) externally before awarding this contract and (d) what advice did the Provincial Treasury provide?

(a) What type of masks was purchased, (b) for whom were these approximately 2 570 000 masks purchased at R15,12 per unit, (c) what processes were followed to ensure that the outsourced procurement function was allowed also to be considered as a supplier for a procurement requirement of his Department, (d)(i) what has been the total spend on Tusk CC from January 2020 to date and (ii) for what purposes and (e)(i) what was the inception date of the contract, (ii) what is the current contract value and (iii) what function is the internal procurement function performing?

- (2) whether any provincial departments, ministries and entities are renting offices at private properties; if so, (a) what are the relevant details and (b) what is the cost breakdown per property?
