# 1. Mr A P van der Westhuizen to ask Dr I H Meyer, Minister of Agriculture:

With reference to his reply to question 5 of 26 November 2021:

- (1) What is the progress as at the latest date for which information is available;
- (2) whether the envisaged date of completion, previously scheduled for 7 July 2022, still applies; if not, what would the effect of further delays be on the ability of the Brandvlei Dam to store additional run-off water during the upcoming rainy season; if so, what are the relevant details?

### 2. Ms N G Bakubaku-Vos to ask Ms S G Fernandez, Minister of Social Development:

- (1) (a) What (i) is the number and (ii) are the details of the old-age homes in the province that are being run by her Department and (b)(i) how many are being subsidised by her Department, (ii) which old-age homes are they, (iii) how many of these are being scheduled for closure and (iv) what are the arrangements being made in the face of their closures?
- (2) (a) what is the number of old-age homes that (i) have been closed, (ii) have not been funded and/or (iii) have had board changes due to non-compliance and (b) what are the details thereof in (i) 2014, (ii) 2015, (iii) 2016, (iv) 2017, (v) 2018, (vi) 2019, (vii) 2020, (viii) 2021 and (ix) 2022 to date?

(a) What is the cost of providing social services, counselling, rehabilitation and child care for the victims of alcohol abuse across the province, (b) what is the cost to her Department to maintain treatment centres for alcohol dependency, child-care services,

rape counselling and other alcohol-related social ills and (c) what are the details of these costs to her Department in (i) 2017, (ii) 2018, (iii) 2019, (iv) 2020 and (v) 2021?

With regard to the Better Living Model as seen at Conradie Park:

- (1) Whether there is a document that outlines the aims, rationale and philosophy of the Better Living Model; if so, can a copy be made available;
- (2) as Conradie Park is the pilot project for the Better Living Model, whether his Department plans to implement this model elsewhere; if not, why not; if so, (a) where and (b) what are the anticipated timelines for these projects?

- (2) whether his Department plans to engage with the national government about adding foreign vehicles that enter South Africa at border posts to such a database; if not,

how does the Department intend to enforce traffic regulations regarding foreign-registered vehicles and/or foreign drivers; if so, what are the relevant details?

# 9. Mr C M Dugmore to ask Mr A R Winde, Premier:

With regard to the Conradie Better Living Model:

- (1) Whether any public funds have been spent on the project since its inception to date; if not, why not; if so, (a)(i) how much of these funds were spent on consultants, (ii) what is the detailed breakdown of the consultants who were paid and (iii) what is the empowerment status of each of these consultants;
- (2) what is the total (a) number of beneficiaries who benefitted, (b) amount in state subsidies awarded to them to date and (c) anticipated amount in subsidies that will be spent at the completion of this project;
- (3) whether provision was made for the building of a public primary and high school on the property; if not, why not; if so, what are the relevant details;
- (4) (a) what process was followed to determine which private education provider will operate the schools on the premises and (b) what are the details of the minutes of meeting where these decisions were taken;
- (5) whether such providers will pay rental for the properties on which the school or schools are to be built; if not, why not; if so, what are the relevant details;
- (6) whether any black-owned companies will benefit from this project; if not, why not; if so, (a) what are the details of such companies and (b) what is the extent to which they will benefit from the project?

Whether his Department has established community Wi-Fi hotspots in any of the 406 wards in the province; if not, why not; if so, (a) in how many wards have they been established and (b) at which physical addresses have they been provided, including the ward number and physical address of each Wi-Fi hot-spot?

(a) (i) What is the number of learners who were placed at schools on the 15th school day in the province and (ii) how many were unplaced and (b)(i) what is the number of learners who have not been placed at the Murray High School and (ii) what are the reasons therefor?

- (4) (a) what relationship does her Department have with CPFs in the province and (b) what are the details of the meetings that were held with each CPF over the past 12 months?

- (2) whether there are plans in place to ensure that security fences at 30 schools will be built each year from 2019/20 to the end of the sixth administration?
