(a) How many students were supported by his Department with full-cost study bursaries in (i) 2018/19, (ii) 2019/20 and (iii) 2020/21, (b) what was the average annual bursary amount per student, (c) how many of the students, who graduated successfully during this period with the financial assistance of his Department, were not absorbed into the payroll of his Department and (d) what were the qualifications of those bursary holders who could not be absorbed?

  (b) what are the details of the school infrastructure projects that took place in the communities of (i) Mfuleni, (ii) Kraaifontein, (iii) Khayelitsha and (iv) Mitchells Plain in (aa) 2014, (bb) 2015, (cc) 2016, (dd) 2017, (ee) 2018, (ff) 2019, (gg) 2020, (hh) 2021 and (ii) 2022 to date?

- (1) (a) What are the details of the findings of the investigation into the sexual misconduct of former Minister Fritz and (b) what recommendations were made;
- (2) whether the report of the investigation will be made available to the (a) Standing Committee on Community Safety and (b) Western Cape Provincial Parliament; if not, why not; if so, what are the relevant details;
- (3) (a) how much was spent on this investigation and (b) from which programme or programmes were the funds taken;
- (4) what measures is he going to put in place to prevent a reoccurrence of this conduct and the victimisation of young women in the workplace by a member of his Cabinet?

- (2) (a) how much of the 2021/22 budget has been allocated to programmes and initiatives in protection, aid and support of people in the LGBTQIA+ community, (b) how has she supported this community in her term, (c) what are the policy priorities of her Department in this regard and (d) what support services does her Department offer to the transgender community?
