3. Recommendations/Actions

- 3.1.1 That Mr Lionel Esterhuizen be considered as the first preference for the chairperson's position and Ms Sibongile Morara as the second preference; and
- 3.1.2 That Ms Marion Wannenberg be considered as an ordinary member.
- 3.2 The Committee deliberated on the appointment of the alternate members and concluded that the Department advertise to appoint two alternate members who have expertise in consumer matters pertaining to rental housing. This was decided on the premise that none of the candidates were qualified in consumer matters.
