1. Opening and Welcome

2. Briefing by the Department of Human Settlements

- 3.1.1 List of its current projects and a list of the 15 planned projects aligned to the Integrated Development Plan based on the objectives of Outcome 8 and representing national and provincial priorities as depicted on page five of the presentation;
- 3.1.2 List of the historically disadvantaged individual's namely female small, medium and micro-sized enterprise contractors that were upgraded by the Department as depicted on page seven of the presentation;
- 3.1.3 Report on strategies put in place to deal with climate change and the social aspects of mass development; and
- 3.1.4 List of the available land suitable for human settlement within the Western Cape, owned by national and provincial government.
- 3.2 The Committee REQUESTED that the Department brief it on the:
- 3.2.1 Conradie and Retreat Better Living Model and how it will be implemented in other areas; and
- 3.2.2 Current financial year's business plans.
- 3.3 The Committee RECOMMENDED that the Department consider providing municipalities with the opportunity to retain the Human Settlements Development Grant to finalise the existing projects tied to the Grant.
- 3.4 The Committee RESOLVED that the Department provide it with presentations at least four days prior to a Standing Committee meeting.
