7. [16:31] Mr R B Lentit moved without notice: That the House congratulates Mr R van Staden, currently an educator at the Athlone School for the Blind in Bellville South, who –
 - (1) completed his school career from Grade 1 to Grade 12 at this special school; and
 - (2) after completing his matric, studied and achieved his educational qualification at the University of the Western Cape.

Agreed to.
8. Ms V Hani moved without notice: That the House—
 - (1) extends its condolences to the families and friends of the people who lost their lives in the Kayamandi shack fires on Thursday, 14 March 2013; and
 - (2) sympathises with all the injured persons and displaced families who lost all their belongings in this devastating fire.

Agreed to.
9. Mr E J von Brandis moved without notice: That the House—
 - (1) expresses its deepest sympathy with the families of all the victims of the horrific bus accident in Hex River Pass and with those who were injured in this tragic accident on Friday, 15 March 2013;

- (2) notes that the passengers on the bus were all members of the Twelve Apostles Church in Christ in Khayelitsha on their way back to Cape Town from Secunda; and
- (3) wishes all the injured a speedy recovery.

10. Mr A M Figlan moved without notice: That the House notes with great gratitude and appreciation that, on Monday 18 March 2013, the late Mr Hassan Howa, one of the founding members of the anti-apartheid South African Cricket Board of Control (SACBOC), was posthumously honoured with an honorary doctorate degree (DPhil in Community and Health Sciences) from the University of the Western Cape.

11. Mr G R C Haskin moved without notice: That the House –

- (1) notes and supports the significant importance of Earth Hour, a global initiative by the World Wildlife Fund, which takes place on Saturday, 23 March 2013, between 20:30 and 21:30; and
- (2) calls on all electricity users in the Western Cape–
 - (a) to switch off all non-essential appliances working with electricity for that hour; and
 - (b) also to commit to sustain this initiative by permanently changing electricity usage patterns this year and in future years.
