1. The House met at 14:15.
2. The Speaker took the Chair and read the prayer.
3. [14:17] The Chief Whip moved: That the Western Cape *Eighteenth Gambling and Racing Amendment Bill* be referred back to the Standing Committee on Finance, Economic Development and Tourism for further consideration and report.

Agreed to.

7. [15:42] Mr H P Geyer moved without notice: That the House gives recognition to Christians today with the celebration and commemoration of Ascension Day, which is celebrated 40 days after Good Friday.

Agreed to.

8. Mr A M Figlan moved without notice: That the House congratulates Mr Madikizela, the Minister for Human Settlements, on receiving an award from SHRA (the Social Housing Regulatory Authority) for the best province in the country in respect of social housing.

Agreed to.

9. Ms D Gopie moved without notice: That the House congratulates the young detective constable of the South African Police Service, Siphiwo Nteta of Elsies River, on receiving the award for the most enthusiastic and passionate detective in the country.

Agreed to.

10. Mr M G E Wiley moved without notice: That the House –
 - (1) notes with grave concern the ongoing killing of young people in gang-related activities and violence; and

- (2) extends its sympathy to the families of Charles Snyman (15) and Mortima Joubert (19), both shot dead, and Keelan Solomons (20) and Cedrico Hoorn (15), who were critically wounded in Kraaifontein on Saturday, 4 May 2013.

- (1) congratulates the versatile painter and artist, Hannatjie van der Wat, on the extraordinary example set by her to every South African in that, at the memorable age of 90 years, she is still involved in her main passion in life – the creative arts; and
- (2) notes with interest that her art of the past 70 years was displayed recently in an exhibition in Stellenbosch giving an overview of her work.

- (1) extends its condolences to the families and friends of the two learners from Tafelsig who drowned in Monwabisi beach on Workers Day; and

13. Ms A J du Toit Marais moved without notice: That the House congratulates Messrs Zamayedwa Sogayise and Dawood Khan on being unanimously re-elected to serve as the chairperson and deputy chairperson of the Khayelitsha Hospital Board for the 2013/2014 financial year.
