1. The House met at 14:15.
2. The Speaker took the Chair and read the prayer.
3. [14:17] Interpellations.
4. [14:50] The Speaker gave a ruling concerning a remark made by the hon Minister Botha during the debate on 6 June 2013 and directed him to withdraw the remark and apologised.

Whereupon the Minister withdrew the remark and apologised.

6. [15:56] Questions to the Premier without notice.
7. [16:20] Statements by Members.
8. [16:47] Ms M Tingwe moved without notice: That the House extends its condolences to the family and friends of 15-year old Ntobeko Gogo, who was brutally murdered in Delft on 7 June 2013.

Agreed to.

9. Mr M C Walters moved without notice: That the House records its extreme concern at the declining health of our first democratically elected President, Mr Nelson Mandela, and conveys its sincere wishes for his speedy recovery to his nearest and dearest.

Agreed to.

10. Mr R B Lentit moved without notice: That the House –
 - (1) conveys its sincere condolences to the Cloete family of Kuilsrivier on the sudden passing of their son; and
 - (2) wishes them strength and God's comfort during this painful period of mourning.

Agreed to.

11. Ms N P Magwaza moved without notice: That the House –

- (1) extends its condolences to the family and friends of the Overberg regional chairperson of the African National Congress and councillor, Manie Damon, who passed away over the past weekend; and
- (2) notes that he was a champion for the rights of farmworkers.

Agreed to

12. Mr E J von Brandis moved without notice: That the House –

- (1) notes with pride that five residents from the Mother City made the Forbes list of 30 of 30 Africa's Best Young Entrepreneurs, for making the most dramatic impact across the continent of Africa; and
- (2) therefore congratulates the following five young Capetonians: Ashley Uys, Rapelang Rabana, Ludwick Phofane Marishane, Justin Stanford and Sizwe Nzima.

Agreed to.

13. Ms V Hani moved without notice: That the House commends the National Youth Development Agency for opening the Langa house building project where 100 young people will be involved in building 76 houses for the elderly and other vulnerable people in Langa over the next 12 months.

Agreed to.

14. Ms A J du Toit Marais moved without notice: That the House –

- (1) commends the Minister of Social Development and the Department of Social Development in the Western Cape for arranging a unique Youth Day event, where they will not only be celebrating youth but also engaging with young people to get a better idea of what the important issues with regard to youth development are and how they think we should deal with such issues; and
- (2) notes that this event is for 2 350 young people from all races, including young people living with disabilities.

Agreed to.

15. Mr K E Magaxa moved without notice: That the House notes with concern the latest findings of the South African Human Rights Commission on the state of sanitation in certain informal settlements in the City of Cape Town, which in their view represents a crisis that poses a significant risk to the health of the vulnerable communities in our city.

Agreed to.

16. Mr E J von Brandis moved without notice: That the House –

- (1) urges the national Minister of Justice, Mr Jeff Radebe, to reinstate the “name and shame” of drunk drivers campaign; and
- (2) notes that the “name and shame” list stigmatises driving under the influence and reduces the number of drunk drivers for weeks following its publication.

Agreed to.

17. Ms J L Hartnick moved without notice: That the House congratulates Mr Joseph Kholokoane, a 44-year-old petrol attendant of Worcester, on receiving his degree in social sciences after a caring land owner paid all his university fees that were still outstanding after his completing the degree 17 years ago.

Agreed to.

18. Ms A J du Toit Marais moved without notice: That the House –
- (1) expresses its gratitude to the plastic surgeon at the Red Cross Children's Hospital, Dr Saleigh Adams, for the selfless work that he is performing in cooperation with and with the assistance of the Smile Foundation; and
 - (2) notes with appreciation that 19 children have received reconstructive surgery in the past week and that this will make it possible for them to smile again.

Agreed to.

19. [16:55] Having indicated that they would not partake further in the discussions on the Order Paper, the African National Congress left the Chamber.
20. [16:57] The House discussed the following subject in the name of Mr E J von Brandis: The problem of unemployment, especially among the young people of our province and country.
