2. The Deputy Speaker took the Chair and read the prayer.

6. [15:52] Mr H P Geyer moved without notice: That the House expresses its deepest condolences to the family, colleagues and friends of the former Chief Justice Pius Langa, who passed away on Wednesday, July 24, 2013. As one of the first appointed judges in the post- apartheid Constitutional Court, Chief Justice Langa played an extraordinary role as a South African who enriched our communities and its people through his dedicated fight against oppression.
Agreed to.
7. Ms L Brown moved without notice: That the House extends its condolences to the family, friends and comrades of the former Deputy Minister of Social Development and anti-apartheid activist, Jean Swanson-Jacobs who passed away earlier this month.
Agreed to.
8. Mr M G E Wiley moved without notice: That the House expresses its deepest sympathy to the family of Constable Dumile Thethani (38), who died in a hail of bullets while performing his duties in Nyanga on Monday evening.
Agreed to.
9. Ms B G Mbalo moved without notice: That the House extends its condolences to the family, friends, comrades and compatriots of the ANC, SACP member and Gauteng MEC for Economic Development, N'kosiphendule Kolisile who died tragically in a car crash on his way to a funeral in the Eastern Cape.
Agreed to.

10. Mr E J von Brandis moved without notice: That the House congratulates Jacques Burger from Paarl Boys High School and Anke Swart from Paarl Gym High School who, out of hundreds of applicants, were selected to represent South Africa at the annual Nasa Space School Summer Programme in Houston, Texas.

11. Mr M C Walters moved without notice: That the House conveys its congratulations to the Kirstenbosch Botanical Gardens with the celebration of its centenary on 1 July 2013 together with that of the Botanical Society of South Africa, both prestigious organisations of worldwide renown. The foresight shown by the founders of these organisations has left South Africa with assets which continue to reflect the promise and uniqueness of our country.

12. Mr M Ozinsky moved without notice: That the House extends its condolences to the family and friends of Ashelya, Caitlyn and Kegan Manuel who were killed at their home in Grassy Park due to a suspected gas leak.

13. Mr A M Figlan moved without notice: That the House congratulates the City of Cape Town in collaboration with the Department of Human Settlements that have undertaken the Ocean View – Mountain View – stone mason housing project in which the use of natural on-site material was combined with the training in unique-skills job creation on an impressive scale in the design which engender pride in home ownership.

15. Ms A J D Marais moved without notice: That the House welcomes and recognises our community leaders, who exert themselves to promote development and stability in their home neighbourhoods, who are present in the House today to observe the functioning of the parliamentary system in our Province.

16. Mr P Uys moved without notice: That the House congratulates the newly appointed ANC Chief Whip in the National Assembly, Stone Sizani.

17. Mr M G E Wiley moved without notice: That the House –
- (1) expresses its sympathy with the passing on of Vice-Admiral Lambert (Woody) Woodburn, former chief of the Navy and one of the highest decorated officers in the modern era;
 - (2) notes that –
 - (a) Admiral Woodburn, one of South Africa's first submarine commanders, was admired by all who met him and revered by those he led; and
 - (b) his official funeral was held in the Simon's Town naval chapel on 11 July and was addressed by the current Chief of the Navy, Vice-Admiral Mudimu.

18. Mr J J Visser moved without notice: That the House noting the good work the Provincial Departments do and congratulates the Department of Local Government on their speedy reaction on the Auditor General report of non-compliance by municipalities and their development of a software programme which municipalities can use to track their own compliance efforts.

19. Ms J L Hartnick moved without notice: That the House –

- (1) congratulates Professor Robert Millar of the University of Cape Town who was awarded with the National Science and Technology Forum-BHP Billiton lifetime achievement award;
- (2) notes that this is a social recognition of an individual's outstanding contribution to science, engineering and technology (SET) within South Africa, over a lifetime; and
- (3) furthermore congratulates the six finalists for this prestigious award, namely: Professor Dan Stein, Professor Graeme Cumming, Professor Karen Sliwa-Hahnle, Professor Kobus van Zyl, Professor Gerhard de Jager and Professor Mqhele Dlodlo.

20. Ms M Tingwe moved without notice: That the House notes with concern that 2700 Western Cape learners are currently on the waiting list to be placed in schools due to capacity problems and that the Western Cape has the highest numbers of learners in this category.

- (1) congratulates Jeanne-Mari Scholtz, from Sedgfield in the Southern Cape, who last week during the IKA World Open martial arts championships in Orlando, Florida, won five gold medals; and
- (2) notes that she started competing in Eastern martial arts in order to protect herself and her children after the passing away of her husband.

22. Ms J L Hartnick moved without notice: That the House pays tribute to the victims of the St James Church killing that took place 20 years ago in Kenilworth and hopes that something like this should never happen in South Africa again.

23. Ms A J du Toit Marais moved without notice: That the House congratulates Samantha Hayward, a Grade 11 pupil at Herschel Girls School in Claremont, for having her science project shortlisted in the top 90 at the Google Science Fair and was one of three that were chosen in Africa.

24. Mr M G E Wiley moved without notice: That the House –

- (1) congratulates the exceptional efforts of local sportsmen and women at the well-attended recent inaugural World Surfski championships held in Ofir, Portugal, where 380 athletes from 5 continents participated;
- (2) notes that Sean Rice won the men's single ski event, his brother Kenny won the junior men's event, Michele Eray the ladies event and Kirsten Flanagan won the junior women's event;
- (3) acknowledges the exceptional performances of the athletics from Fish Hoek Surf Lifesaving club which contributed 10 athletes to the South African squad, including the Rice brother and Flanagan, who won the majority of the 10 podium finishes that South Africa achieved; and
- (4) further acknowledge that South Africa was the first nation overall at the championships.
